A RESOLUTION OF THE BOARD OF COUNTY  
COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA  
RESCINDING A ROAD NAME FROM LYNHALLA LANE TO TRAIL  
ROAD

WHEREAS, an application has been duly made to the Board of County Commissioners to revert the road name of "Lynhalla Lane" to "Trail Road"

WHEREAS, the procedure outlined in resolution #92-65 has been followed by the petitioners; and

WHEREAS, it is found to be in the public interest to name this street as requested on furtherance of the public health, safety and welfare;

NOW THEREFORE BE IT RESOLVED By the Board of County Commissioners as follows: -

Section 1. The petition to revert the road name of "Lynhalla Lane" to "Trail Road" is hereby granted and road name shall here after be known by that name.

Section 2. The E 9-1-1 Coordinator is instructed to take whatever steps are necessary to change a named street and to notify the Property Appraiser's Office of the change.

Section 3. The petitioner shall notify, in writing, all residents affected by this resolution.
