

RESOLUTION NO. 2004 - 350

**RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING THE TERMS, PROVISIONS, CONDITIONS, AND REQUIREMENTS OF A LANDSCAPING AGREEMENT BETWEEN ST. JOHNS COUNTY, FLORIDA, AND THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION, FOR MAINTENANCE OF LANDSCAPING AND RIGHTS-OF-WAY ON PORTIONS OF STATE ROAD 16 (SR-16) AT ITS INTERSECTION WITH INTERSTATE 5 (I-95) IN ST. JOHNS COUNTY FROM COUNTY ROAD 208 (CR-208) TO INMAN ROAD, AND AUTHORIZING THE COUNTY ADMINISTRATOR TO EXECUTE THE LANDSCAPING AGREEMENT ON BEHALF OF ST. JOHNS COUNTY**

**WHEREAS**, the Board of County Commissioners (Board) of St. Johns County, Florida (County), on August 25, 2004, in preparation for a major sporting event, Super Bowl XXXIX, and for the benefit of residents and visitors in the future, authorized aesthetic enhancements to major gateways leading into the County; and

**WHEREAS**, the Board identified the intersection of SR-16 and I-95 as a major gateway and has requested permission from the Florida Department of Transportation (FDOT) to install non-standard landscaping in the medians of SR-16 from CR-208 east to Inman Road; and

**WHEREAS**, the FDOT does not install or perform maintenance on non-standard landscaping within the State Road Rights-of-Way; and

**WHEREAS**, the Board has appropriated funds for the installation of landscaping in the medians of SR-16 at its intersection with I-95 from CR-208 east to Inman Road; and

**WHEREAS**, the Board agrees to provide for the maintenance of the above-referenced landscaping once installed; and

**WHEREAS**, both the County and the FDOT believe that they should enter into a Landscaping Agreement, so that the County can continue providing for the maintenance of landscaping and rights-of-way, on SR-16, at its intersection with I-95, from CR-208 east to Inman Road; and

**WHEREAS**, the County has reviewed the terms, provisions, conditions, and requirements of the Landscaping Agreement (attached hereto, and incorporated herein); and

**WHEREAS**, the County has determined that accepting the terms of the Landscaping Agreement, and entering into said Landscaping Agreement will serve the interests of the County; and

**WHEREAS**, it is in the collective interests of both the County and FDOT to have the landscaping and routine right-of-way maintenance activities performed by the same entity.


**NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AS FOLLOWS:**

**Section 1.** The above Recitals are hereby incorporated into the body of this Resolution, and are adopted as Findings of Fact.

**Section 2.** The Board of County Commissioners hereby approves the terms, provisions, conditions, and requirements of a Landscaping Agreement between St. Johns County, Florida, and the State of Florida, Department of Transportation, for maintenance of landscaping and rights-of-way on SR-16, at its intersection with I-95, from CR-208 east to Inman Road, and authorizing the County Administrator to execute the Agreement in substantially the form attached, on behalf of the County.
