Section 2. The E 9-1-1 Coordinator is instructed to take whatever steps are necessary to name the unnamed street and to notify the Property Appraiser's Office of the change.

Section 3. The petitioner shall notify, in writing, all residents affected by this resolution.

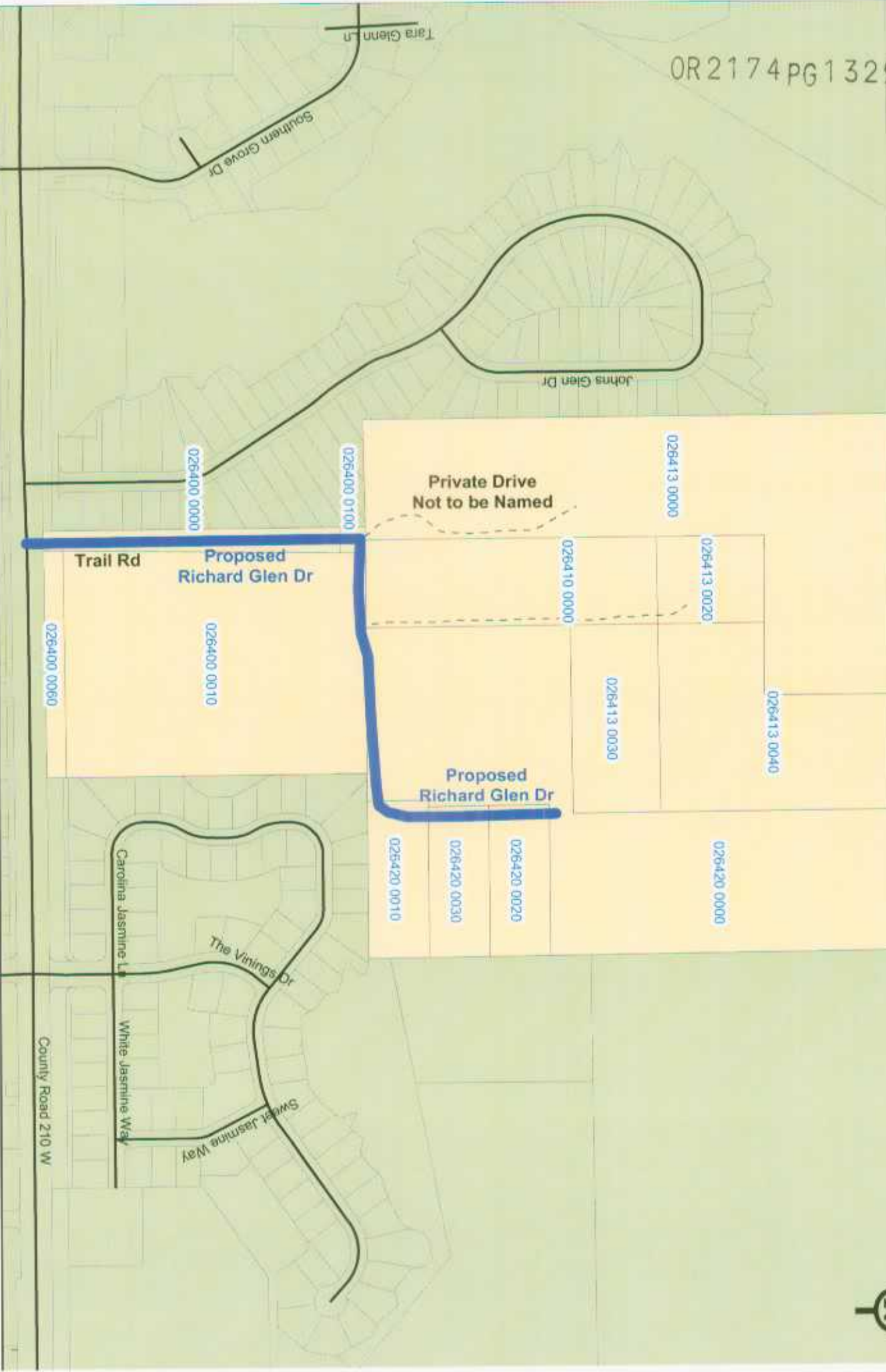
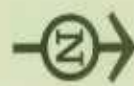
