Section 1. The petition to change a road name from HASTINGS PALATKA RD to OLD HASTINGS RD is hereby granted and shall here after be known by that name.



Section 3. The petitioner shall notify, in writing, all residents affected by this resolution.





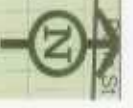
