

RESOLUTION 2005 - 14

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AMENDING THE FISCAL YEAR 2005 GOLF COURSE FUND BUDGET TO RECEIVE UNANTICIPATED REVENUE AND AUTHORIZE ITS EXPENDITURE BY THE GOLF COURSE MAINTENANCE DEPARTMENT.

WHEREAS, the County operating budget is annually prepared prior to knowing the actual amount of Developer Contribution funds which may be received by the Golf Course Fund; and

WHEREAS, St. Johns County, Florida, when preparing the budget for Fiscal Year 2005, did not anticipate receiving Developer Contribution funds from the Cypress Lakes Phase II, LLC; and

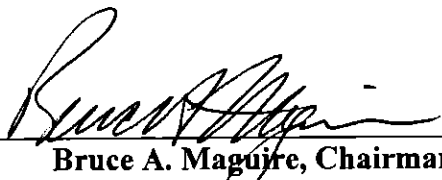
WHEREAS, the Developer has made available \$3,825.92 for the relocation of the golf course irrigation system due to developer impacts.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, that:

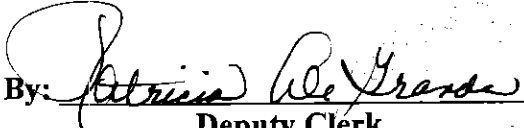
1. The above recitals are hereby adopted as legislative findings of fact.
2. The Golf Course Fund revenue and expenditure budgets shall be adjusted to account for unanticipated funds from the Cypress Lakes Phase II, LLC in the amount of \$3,825.92 for Fiscal Year 2005.

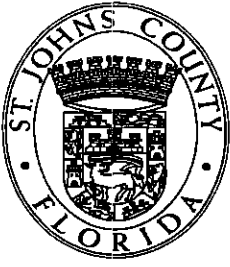
