RESOLUTION 2005 - 16

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AMENDING THE FISCAL YEAR 2005 WATER & SEWER AUTHORITY FUND BUDGET TO RECEIVE UNANTICIPATED REVENUE AND AUTHORIZE ITS EXPENDITURE BY THE WATER & SEWER AUTHORITY DEPARTMENT.

WHEREAS, the County operating budget is annually prepared prior to knowing the actual amount of Rate Case Filing Fees which may be received by the Water & Sewer Authority Fund; and

WHEREAS, St. Johns County, Florida, when preparing the budget for Fiscal Year 2005, did not anticipate receiving Rate Case Filing Fees from Intercoastal Utilities, Inc.; and

WHEREAS, the Utility has paid \$15,000.00 for the costs associated with a Limited Proceeding Case.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, that:

- 1. The above recitals are hereby adopted as legislative findings of fact.
- 2. The Water & Sewer Authority Fund revenue and expenditure budgets shall be adjusted to account for unanticipated funds from Intercoastal Utilities, Inc. in the amount of \$15,000.00 for Fiscal Year 2005.
