**A RESOLUTION OF THE BOARD OF COUNTY

CHANGING A ROAD NAME FROM DAM ROAD TO ASHFORD MILLS
ROAD**

WHEREAS, an application has been duly made to the Board of County Commissioners to change a road name from Dam Road to Ashford Mills Road

WHEREAS, the procedure outlined in resolution #92-65 has been followed by the petitioners; and

WHEREAS, it is found to be in the public interest to name this street as requested on furtherance of the public health, safety and welfare;

NOW THEREFORE BE IT RESOLVED By the Board of County Commissioners as follows:

Section 1. The petition to change a road name from Dam Road to Ashford Mills Road is hereby granted and shall here after be known by that name.

Section 2. The E 9-1-1 Coordinator is instructed to take whatever steps are necessary to change the name of the road and to notify the Property Appraiser's Office of the change.

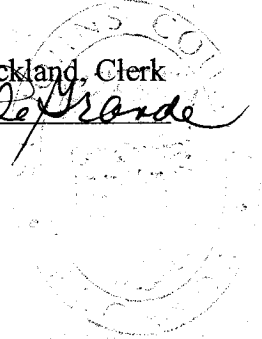
Section 3. The petitioner shall notify, in writing, all residents affected by this resolution.

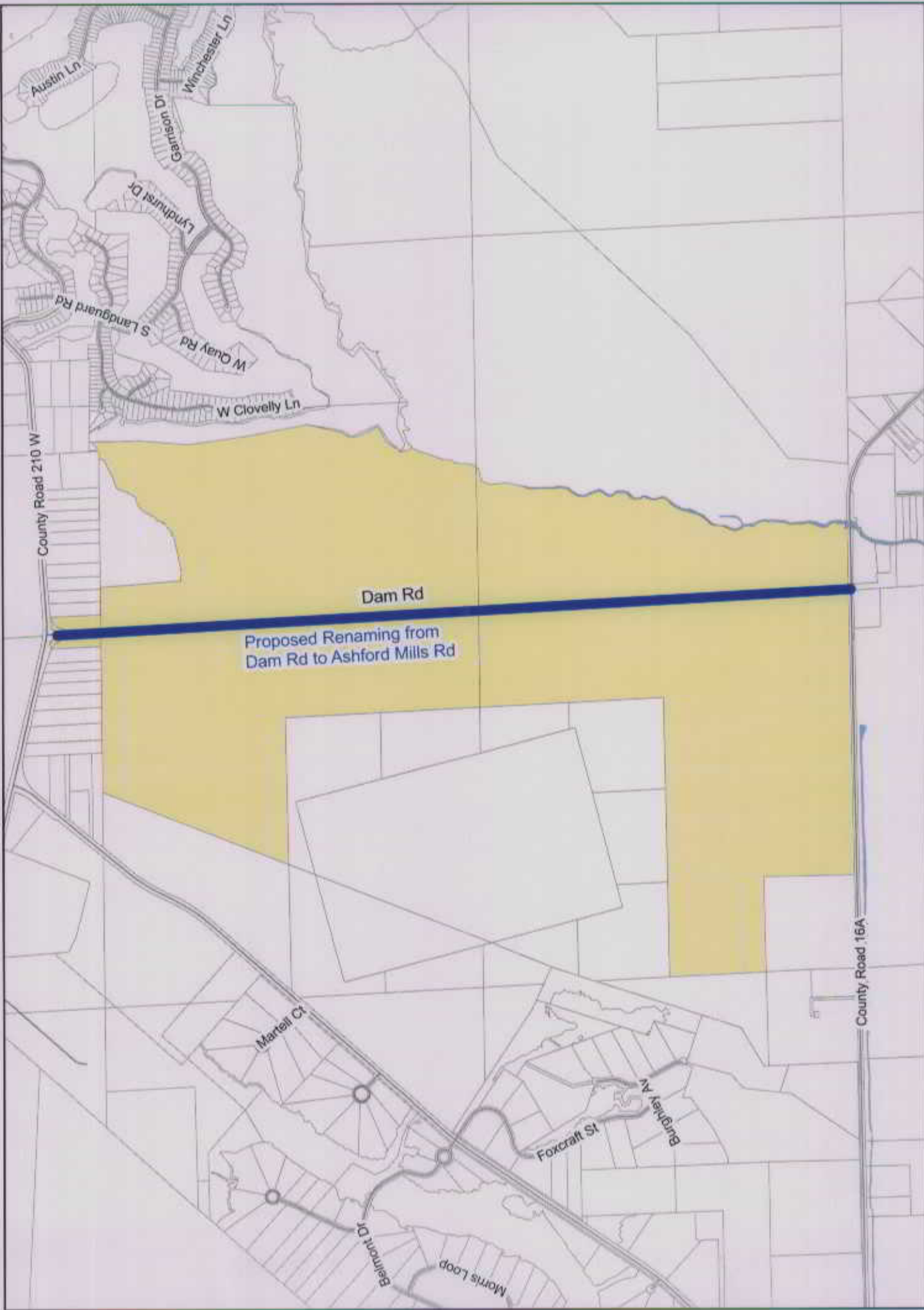
