## RESOLUTION NO 2005 - 218

#### A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA NAMING A PRIVATE DRIVEWAY WOODFERN LANE

WHEREAS, an application has been duly made to the Board of County Commissioners to name a private driveway Woodfern Lane.

WHEREAS, the procedure outlined in resolution #92-65 has been followed by the petitioners; and

WHEREAS, it is found to be in the public interest to name this street as requested on furtherance of the public health, safety and welfare;

NOW THEREFORE BE IT RESOLVED By the Board of County Commissioners as follows:

Section 1. The petition to name a private driveway Woodfern Lane is hereby granted and shall here after be known by that name.

Section 2. The E 9-1-1 Coordinator is instructed to take whatever steps are necessary to name the private driveway and to notify the Property Appraiser's Office of the change.

Section 3. The petitioner shall notify, in writing, all residents affected by this resolution.
