**A RESOLUTION OF THE BOARD OF COUNTY  
COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA  
NAMING A PRIVATE EASEMENT REPUBLIC DRIVE**

WHEREAS, an application has been duly made to the Board of County Commissioners to name a private easement Republic Drive.

WHEREAS, the procedure outlined in resolution #92-65 has been followed by the petitioners; and

WHEREAS, it is found to be in the public interest to name this street as requested on furtherance of the public health, safety and welfare;

NOW THEREFORE BE IT RESOLVED By the Board of County Commissioners as follows:

Section 1. The petition to name a private easement Republic Drive is hereby granted and shall here after be known by that name.

Section 2. The E 9-1-1 Coordinator is instructed to take whatever steps are necessary to name a private easement and to notify the Property Appraiser's Office of the change.

Section 3. The petitioner shall notify, in writing, all residents affected by this resolution.

JOHNS COUNTY, FLORIDA, THENCE SOUTH 40° 23' 59" EAST ALONG SAID NORTHEASTERLY LINE, A DISTANCE OF 1340.00 FEET; THENCE NORTH 49° 36' 01" EAST, 1140.00 FEET; THENCE SOUTH 40° 23' 59" EAST, 146.76 FEET TO THE CENTERLINE POINT OF BEGINNING OF A 100 FOOT WIDE PARCEL LYING 50.00 FEET ON EACH SIDE OF THE FOLLOWING DESCRIBED CENTERLINE:

THENCE NORTH 20° 28' 52" WEST, 1300.04 FEET MORE OR LESS TO THE AFOREMENTIONED SOUTHERLY RIGHT-OF-WAY LINE OF NINE MILE ROAD AS NOW MONUMENTED, AND THE POINT OF TERMINATION. SIDELINES TO BE LENGTHENED OR SHORTENED AS NECESSARY TO COMMENCE ON A LINE WHICH BEARS SOUTH 40° 23' 59" EAST (NORTH 40° 23' 59" WEST) FROM THE POINT OF BEGINNING, AND TO TERMINATE ON THE SOUTH RIGHT-OF-WAY LINE OF NINE MILE ROAD (AS FIELD MONUMENTED BEARING NORTH 59° 05' 11" EAST/SOUTH 59° 05' 11" WEST FROM THE POINT OF TERMINATION).
