

RESOLUTION 2005 - 344

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AMENDING THE FISCAL YEAR 2006 LAW ENFORCEMENT TRUST FUND TO RECEIVE UNANTICIPATED REVENUE AND AUTHORIZE ITS EXPENDITURE BY THE ST. JOHNS COUNTY SHERIFF.**

**WHEREAS**, the County operating budget is annually prepared prior to knowing the actual amount of funds which may be received by the Law Enforcement Trust Fund from the sale of confiscated property; and

**WHEREAS**, St. Johns County, Florida, when preparing the budget for Fiscal Year 2006, did not anticipate the appropriation of these funds from the sale of confiscated property above and beyond those projected; and

**WHEREAS**, the revenue from the sale of confiscated property amounts to \$22,109.20.

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida, that:

1. The above recitals are hereby adopted as findings of fact.
2. The Law Enforcement Trust Fund revenue and expenditure budgets shall be adjusted to account for unanticipated funds from the sale of confiscated property and unclaimed funds in the amount of \$22,109.20 for Fiscal Year 2006.

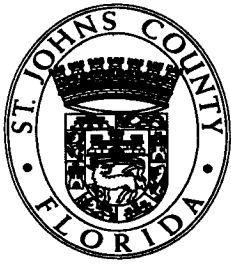
