

RESOLUTION 200 - 380

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AMENDING THE FISCAL YEAR 2006 FIRE DISTRICT BUDGET TO RECEIVE UNANTICIPATED REVENUE AND AUTHORIZE ITS EXPENDITURE BY THE ST. JOHNS COUNTY FIRE-RESCUE DEPARTMENT.**

**WHEREAS**, the County operating budget is annually prepared prior to knowing the actual amount of grant funds which may be received by the Fire District; and

**WHEREAS**, St. Johns County, Florida, when preparing the budget for Fiscal Year 2006, did not anticipate receiving grant funds from the State of Florida above and beyond those projected by the Fire-Rescue Department; and

**WHEREAS**, the State of Florida Domestic Preparedness Strategy has made available from the U.S. Department of Homeland Security Office of Domestic Preparedness additional grant dollars for the purchase of supplies and consumable items to sustain WMD equipment provided under previous grants; and

**WHEREAS**, the State of Florida Domestic Preparedness Strategy has approved additional grant funds to St. Johns County for Fiscal Year 2006 that exceed budgeted grant amounts by \$ 10,363.91.

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida, that:

1. The above recitals are hereby adopted as legislative findings of fact and incorporated herein.
2. The Fire District revenue and expenditure budgets shall be adjusted to account for unanticipated funds from the State of Florida Domestic Preparedness Strategy in the amount of \$10,363.91 for Fiscal Year 2006.

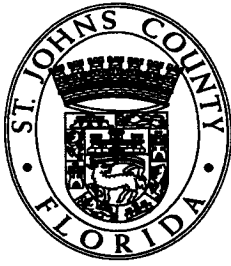
