

RESOLUTION NO. 2005- 340

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING AN EXTRAORDINARY RATE ADJUSTMENT AS ALLOWED UNDER SECTION 9.3 OF SEABOARD WASTE SYSTEM'S RESIDENTIAL SOLID WASTE FRANCHISE CONTRACT WITH ST. JOHNS COUNTY, FLORIDA, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, St. Johns County, Florida (County) currently has a Residential Solid Waste Franchise Contract with Seaboard Waste Systems (Seaboard), which is attached hereto, and incorporated hereby, as Exhibit A; and

WHEREAS, under Section 9.3 of Seaboard's Residential Solid Waste Franchise Contract with the County, Seaboard can request an extraordinary rate adjustment under certain circumstances; and

WHEREAS, Seaboard has requested an extraordinary rate adjustment based on the independent fuel indicator table prepared by the Florida Department of Transportation, which is attached hereto, and incorporated hereby, as Exhibit B; and

WHEREAS, it is expected that the fuel adjustments will vary based on fluctuations to the Florida Department of Transportation Tables; and

WHEREAS, based on the information and documentation supplied by Seaboard, the requested extraordinary rate adjustment is justified; and

WHEREAS, based on the information and documentation supplied by Seaboard, the County may approve the extraordinary rate adjustment as allowed and permitted under Section 9.3 of Seaboard's Residential Solid Waste Franchise Contract with the County.

NOW THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of St. Johns County, Florida, that:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution, and said Recitals are adopted as Findings of Fact.

Section 2. Pursuant to Section 9.3 of the Solid Waste Franchise Contract between Seaboard Waste Systems, and St. Johns County, Florida, the County grants an extraordinary rate adjustment in the amount allowed by, and to the extent permitted by Section 9.3 of the Franchise Contract, and the independent fuel indicator table prepared by the Florida Department of Transportation.

Section 3. Pursuant to Section 9.3 of the Solid Waste Franchise Contract between Seaboard Waste Systems, and St. Johns County, Florida, and until repealed and/or modified by subsequent Resolution of the Board of County Commissioners of St. Johns County, Florida, the County authorizes future adjustments based on future

fluctuations of the Florida Department of Transportation Tables, and a no more than quarterly request by Seaboard.

Section 4. This Resolution is effective as of December 15, 2005.

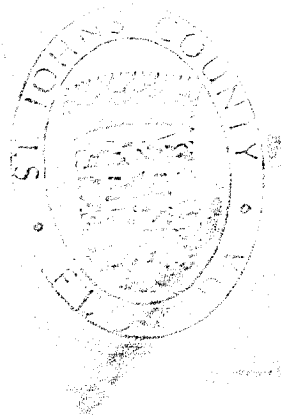

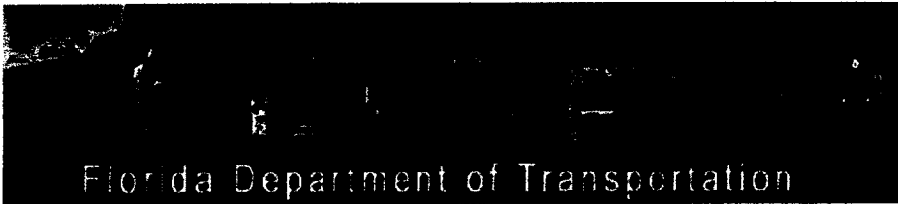
