be and the same are hereby abandoned, and this Board hereby renounces and disclaims any right of the County and the Public in and to the above described roads, as dedicated by the adoption and dedication on the plat as referenced.

- 3. St. Johns County does hereby convey said interest to the Greenfield of St. Johns' Homeowners Association, under the authority granted by Section 316.00825, Florida Statutes.
- 4. That said road abandonment and conveyance are effective on the date this Resolution is duly signed.

5. That the applicant shall pay all recording costs and any other costs that may be necessitated by this action...
