

RESOLUTION 2006 - 15

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AMENDING THE FISCAL YEAR 2006 TRANSIT SYSTEM FUND TO RECEIVE UNANTICIPATED REVENUE AND AUTHORIZE ITS EXPENDITURE FOR THE FEDERAL TRANSIT ADMINISTRATION GRANT ASSOCIATED WITH THE TRANSIT SYSTEM DEPARTMENT.

WHEREAS, the County operating budget is annually prepared prior to knowing the Federal Transit Administration appropriation available for which St. Johns County may apply; and

WHEREAS, St. Johns County, Florida, when preparing the budget for Fiscal Year 2006, did not anticipate additional Federal Transit Administration appropriations in the amount of \$257,989; and

WHEREAS, on December 13, 2005, the BOCC adopted Resolution 2005-391 authorizing the filing of an application and execution of an agreement with the Federal Transit Administration for federal transportation assistance; and

WHEREAS, St. Johns County needs their recognition as current year revenues to enable the appropriation of these funds for their intended purposes;

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, that:

1. The above recitals are hereby adopted as legislative findings of fact.
2. The Transit System revenue and expenditure budgets shall be adjusted to account for an increase award amount reflected in the application with the Federal Transit Administration in the total amount of \$1,258,224 for Fiscal Year 2006.
