to change the name of the street and to notify the Property Appraiser's Office of the change.

Section 3. The petitioner shall notify, in writing, all residents affected by this  
resolution.



The purpose of this memorandum is to request that W Vistana Dr be renamed W Grande Villas Dr. The petitioner is the sole owner of the property and road.

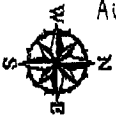

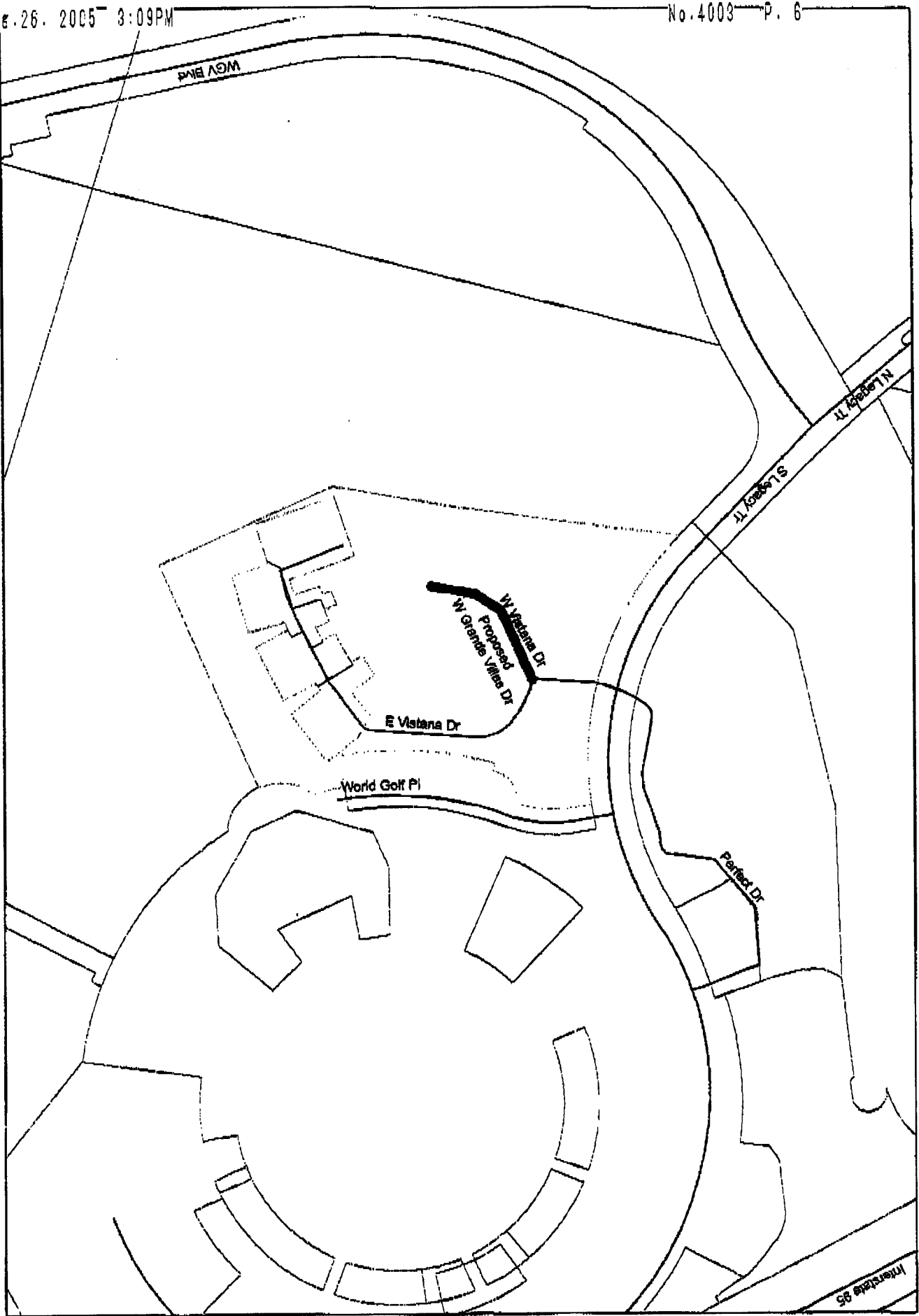
