resolution.



The purpose of this memorandum is to request that E Vistana Dr be renamed E Grande Villas Dr. The petitioner is the sole owner of the property and road.

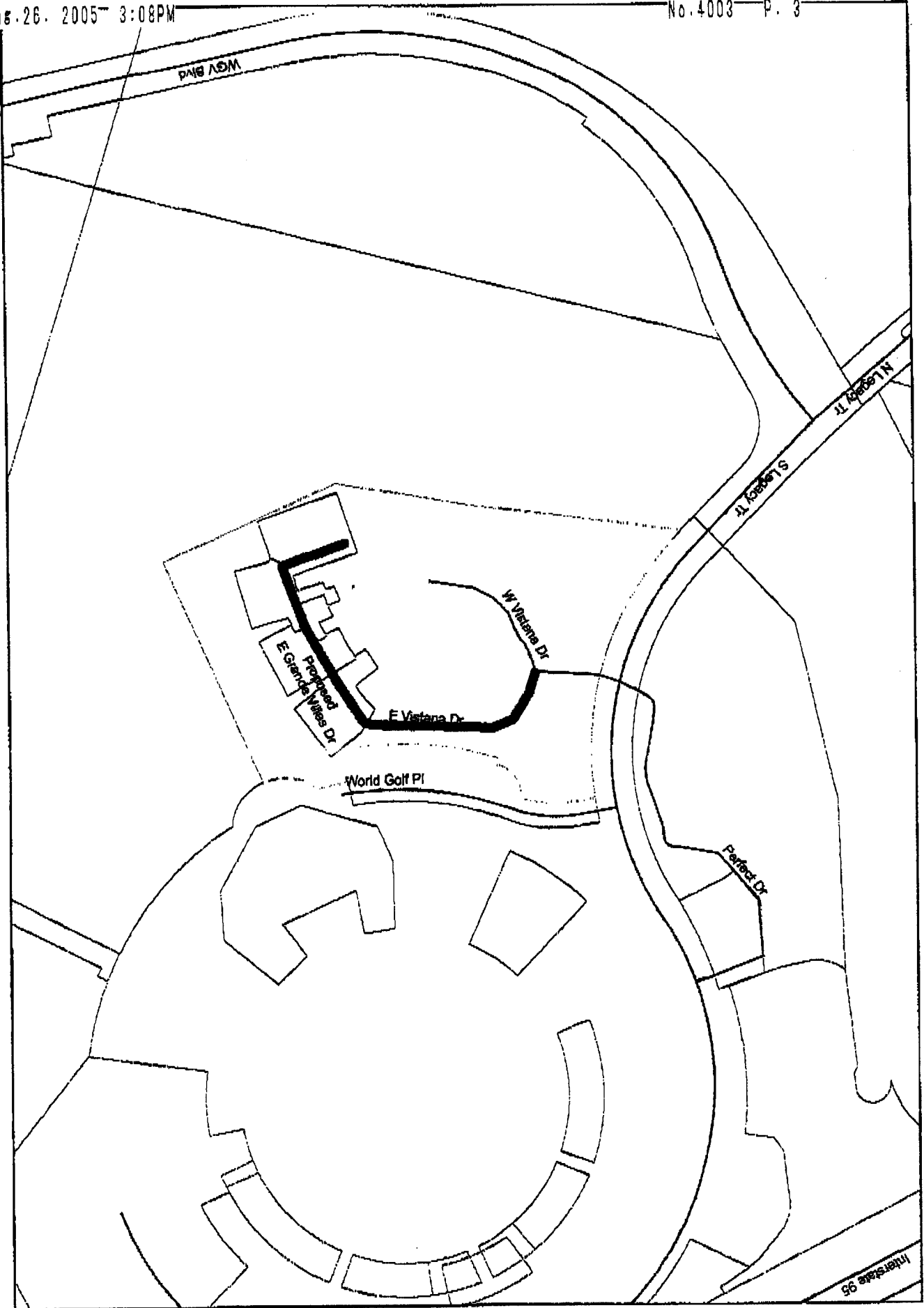
