A petition to change the name of Maple Rd to Maple Tree Ln was submitted to the County where at least 51% of the owners signed the petition. Per the St. Johns County Land Development Code Article VI Section 6.02.03 a notice was sent on May 3, 2007 to the adjoining land owners and the owners of the subject roadway, if any. The owners had 15 days to respond to the notice with any objections to the road renaming petition. No responses were received. The roadway name change has been considered and is hereby approved by the County Administrator or his designee.

Notice of Intent to Change a Roadway Name

Maple Rd to Maple Tree Ln

The purpose of this notice is to advise you that a petition to rename the above named road has been received by the County. That petition (see attached) has been signed by at least 51% of the property owners on the roadway. This petition is being processed in accordance with the St. Johns County Land Development Code Article VI Section 6.02.03.

The road proposed to be renamed is Maple Rd in Elkton. The proposed new road name is Maple Tree Ln. A map of the subject road is attached. The road renaming was initiated by the County since there was already a Maple Rd in St. Augustine South that had numerous residences addressed off of it for many years. As you know Maple Rd in Elkton was a dirt road with no residences addressed off the road until recently. Several months ago an E911 Emergency call to a property in the vicinity of Maple Rd (Elkton) caused the County to review the area's road names and numerical addresses. During that review we found some inconsistencies which have since been corrected with the exception of the road name of Maple Rd.

The name Maple Tree Ln was selected to perpetuate the intent of the original development plat of having a tree oriented name. Tree and Ln were used to differentiate between this road and the road in St. Augustine South so that emergency response teams could better identify where the E911 call originated from. It is in the public interest to rename this street to further the public health, safety, and welfare.

You have fifteen (15) days to send your response to this notice. If there is no response in opposition received, the County Administrator will consider the roadway name change petition and approve or deny the request.

If there is opposition received to the roadway name change petition and alternate names are considered, the County Administrator may schedule a public hearing with the Board of County Commissioners. Notice will be mailed at least ten (10) days before the hearing. Those in favor or against the petition will have an opportunity to present their position on the matter before the Board of County Commissioners. The board will approve or deny the request for the roadway name change.

The County will notify the property owners owning or abutting the roadway affected stating the outcome of the hearing as to whether the road renaming petition was approved or denied. If approved, the County will notify the property owners affected with their change of address.

A form has been provided below for your convenience if you chose to use it. If you are not opposed to road renaming it is not necessary to notify the County.
