

RESOLUTION NO. 2007 - 153

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE AMENDMENT TO THE CONTRACT BETWEEN ST. JOHNS COUNTY BOARD OF COUNTY COMMISSIONERS AND FLORIDA DEPARTMENT OF JUVENILE JUSTICE.

WHEREAS, the State of Florida Department of Juvenile Justice (DJJ) contracts with St. Johns County Board of County Commissioners to provide mental health at St. Johns Regional Juvenile Detention Center, and

WHEREAS, DJJ has submitted a third amendment to the existing contract, and

WHEREAS, DJJ has amended the contract with the purpose of continuing the contract an additional 24 months from July 1, 2007 through June 30, 2009, the total award amounting to \$246,960.00, and


WHEREAS, it is in the best interest of the citizens of St Johns County to continue providing mental health services at the St. Johns Regional Juvenile Detention Center.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, THAT:


1. The above recitals are incorporated by reference into the body of this resolution and such recitals are adopted as Findings of Fact.
2. The Board of County Commissioners of St. Johns County, Florida, hereby approves the terms and conditions of the Amendment to the Contract between St. Johns County, Florida and Florida Department of Juvenile Justice, and authorizes the County Administrator to execute the Amendment on behalf of the County.
3. The Mental Health revenue and expenditure budgets shall be adjusted to account for an increased award amount for fiscal year 06-07 reflected in the contract amendment from DJJ in the amount of \$30,870.

The purpose of this Amendment is to renew this Contract for a period of two (2) years pursuant to Section III. B., of the Contract.

THIS AMENDMENT, entered into between the **STATE OF FLORIDA, DEPARTMENT OF JUVENILE JUSTICE**, ("Department") and **BOARD OF COUNTY COMMISSIONERS, ST. JOHN'S COUNTY** ("Provider"), amends the above-referenced Contract by deleting, as indicated by "~~strikethrough~~" or reference and adding, as indicated by "underscore" or reference the section(s) below:

For the purposes of Section II., F., the psychiatrist rate per hour is \$250.00 and the mental health professional's rate per hour is \$50.00.~~

ADD: 1. The Department will pay the Provider on a fixed price basis in the amount of \$3,250.00 for the period of July 1, 2005 through January 31, 2007 and \$10,290.00 for the period of February 1, 2007 through June 30, 2009, monthly, upon receipt of a properly itemized invoice and pursuant to subsections (C) through (J) below. For the purposes of Section II., F., the psychiatrist rate per hour is \$250.00 and the mental health professional's rate per hour is \$50.00.

REFERENCE: Page 3, Section III., A, Contract Term and Renewal

DELETE: ~~This Contract shall begin on July 1, 2005, or upon execution by both parties (whichever is later) and end at midnight on June 30, 2007, inclusive.~~

ADD: This Contract shall begin on July 1, 2005 and end at midnight June 30, 2009, inclusive.

This Amendment shall become effective on July 1, 2007. All terms and conditions of said original Contract and any attachments and amendments thereto shall remain in full force and effect for this Amendment. Any provisions of said original Contract and any supplements and amendments thereto in conflict with this Amendment shall be and are hereby changed to conform to this Amendment. This Amendment is hereby made a part of the Contract.

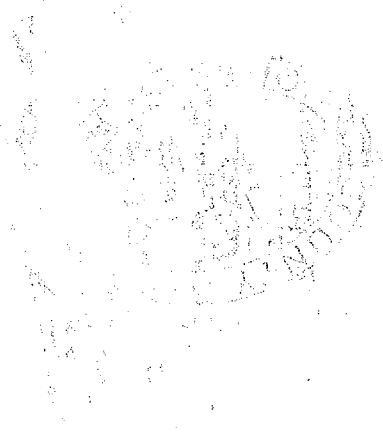
