A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, ON BEHALF OF THE ST. JOHNS COUNTY MENTAL HEALTH DEPARTMENT ACCEPTING THE TERMS OF THE COORDINATION AGREEMENT BETWEEN THE CHILDREN'S HOME SOCIETY/HEALTHY FAMILIES ST. JOHNS AND ST. JOHNS COUNTY, AND AUTHORIZING THE COUNTY ADMINISTRATOR TO EXECUTE THE COORDINATION AGREEMENT ON BEHALF OF THE COUNTY.

WHEREAS, the Children's Home Society/Healthy Families of St. Johns wishes to enter into an agreement effective the date signed by both parties and continuing in effect until June 30, 2008; and,

WHEREAS, the purpose of the Coordination Agreement is to establish a collaboration between the Children's Home Society and St. Johns County Mental Health Department in serving families with small children (birth to 5 years) in St. Johns County.


NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, THAT:

1. The above recitals are hereby adopted as legislative findings of fact.
2. The Board approves the terms of the Coordination Agreement between the Children's Home Society/Health Families St. Johns, and St. Johns County, and authorizes the County Administrator to execute the Coordination Agreement attached and included hereto, on behalf of the County.



Coordination Agreement
Between St. Johns County Board of County Commissioners, on behalf
of St. Johns County Mental Health Department and the Children's
Home Society/Healthy Families St. Johns Program

Children's Home Society/Healthy Families St. Johns agrees to collaborate with the St. Johns Community Mental Health Center. Healthy Families St. Johns is a positive parenting program that promotes parent child interaction from the critical period of birth to five years and seeks to address poor childhood outcomes such as abuse and neglect.

St. Johns County Mental Health Department provides mental health services to residents of St. Johns County.

This agreement is for the period of July 1, 2007 to June 30, 2008.

Both programs agree to:

- make appropriate referrals;
- share service eligibility information; and
- Member serve as Chair of the Advisory Council for a one year term.

In-kind Donation

In addition, St. Johns County Board of County Commissioners on behalf of St. Johns County Mental Health Department agrees to have a representative serve on the CHS/Healthy Families Advisory Board. The Advisory Board will meet for 10 hours during the year with an estimated in-kind contribution of \$35.00 per hour or \$350.00 for the year. In addition, in-kind of mileage is included at \$25.00 for the year.
