WHEREAS, the State of Florida Department of Juvenile Justice (DJJ) contracts with St. Johns County Board of County Commissioners to provide mental health at St. Johns Regional Juvenile Detention Center, and

WHEREAS, DJJ has submitted a fourth amendment to the existing contract, and

WHEREAS, DJJ has amended the contract with the purpose of authorizing the use of a Psychiatric Advanced Registered Nurse Practitioner (ARNP) to provide services to St. Johns Regional Juvenile Detention Center when the psychiatrist is not available, and

WHEREAS, it is in the best interest of the citizens of St Johns County to continue providing mental health services at the St. Johns Regional Juvenile Detention Center.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, THAT:

- 1. The above recitals are incorporated by reference into the body of this resolution and such recitals are adopted as Findings of Fact.

The Board of County Commissioners of St. Johns County, Florida, hereby approves the terms and conditions of the Amendment to the Contract between St. Johns County, Florida and Florida Department of Juvenile Justice, and authorizes the County Administrator to execute the Amendment on behalf of the County.

DEPARTMENT OF JUVENILE JUSTICE FORTH CONTRACT AMENDMENT **FOR** BOARD OF COUNTY COMMISSIONERS, ST. JOHN'S COUNTY

The purpose of this Amendment is to modify the Contract by authorizing the use of a Psychiatric Advanced Registered Nurse Practitioner (ARNP) when the psychiatrist is not available, pursuant to Section VIII., AB., Modification or Re-negotiation. This amendment does not increase costs.

THIS AMENDMENT, entered into between the STATE OF FLORIDA, DEPARTMENT OF JUVENILE JUSTICE, ("Department") and BOARD OF COUNTY COMMISSIONERS, ST.
