## **RESOLUTION 2007 - 389**

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, RECOGNIZING UNANTICIPATED REVENUES OF \$83,000 FROM A FLORIDA DEPARTMENT OF TRANSPORTATION SERVICE DEVELOPMENT GRANT AND AUTHORIZE THEIR EXPENDITURE BY ST. JOHNS COUNTY FOR TRANSIT OPERATIONS AND TO ADJUST THE TRANSIT REVENUE AND EXPENDITURE BUDGET IN RECOGNITION OF THESE FUNDS.

WHEREAS, the County operating budget is annually prepared prior to knowing the actual amount of revenues which may be received by the Florida Department of Transportation for transit expenditures; and

WHEREAS, St Johns County Florida, when preparing the budget for Fiscal Year 2008, did not anticipate receiving Florida Department of Transportation grant revenues for transit operations; and

WHEREAS, On October 2, 2007 Resolution 2007-280 to execute a Supplemental Joint Participation Agreement, Financial Project (FP) # 217141-2-84-07, between the Florida Department of Transportation and St Johns County was passed an adopted by the St Johns County Board of County Commissioners; and

WHEREAS, the Supplemental Joint Participation Agreement, Financial Project (FP) # 217141-2-84-07 made available Service Development Grant revenues in the amount of \$83,000 to provide operating assistance for transit operations; and

WHEREAS, these unanticipated revenues from the Florida Department of Transportation Service Development Grant in the amount of \$83,000 will be expended by St Johns County for transit operations.

WHEREAS, these unanticipated revenues from the Florida Department of Transportation Service Development Grant funds exceed the St. Johns County Fiscal Year 2008 budgeted transit amounts by \$83,000.

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida, that:

- 1. The above recitals are incorporated by reference into the body of this resolution and such recitals are adopted as findings of fact.
- 2. Unanticipated revenues of \$83,000 from a Florida Department of Transportation Service Development Grant be recognized and authorize their expenditure for St Johns County transit operations
- 3. The St Johns County Transit Fund revenue and expenditure budget be adjusted to account for the unanticipated revenues from the Florida Department of Transportation Service Development Grant in the amount of \$83,000 for Fiscal Year 2008.
