A petition to name an unnamed easement to Dairy Barn Rd was submitted to the County where at least 51% of the owners signed the petition. Per the St. Johns County Land Development Code Article VI Section 6.02.03 a notice was sent on July 10, 2007 to the adjoining land owners and the owners of the subject roadway, if any. The owners had 15 days to respond to the notice with any objections to the road renaming petition. No responses in opposition were received. The roadway name change has been considered and is hereby approved by the County Administrator or his designee.

Notice of Intent to Name an Unnamed Easement

to Dairy Barn Rd

The purpose of this notice is to advise you that a petition to name an unnamed easement has been received by the County. That petition (see attached) has been signed by at least 51% of the property owners on the easement. This petition is being processed in accordance with the St. Johns County Land Development Code Article VI Section 6.02.03.

Prior to Meadowlark Ln being constructed and the improvements to Pacetti Rd being completed access to the dwellings on the unnamed easement were by way of Pacetti Rd. Since there is no longer an access point on Pacetti Rd it has become confusing to service providers, among others, to find the dwellings by address.

As many of you know a neighborhood meeting was held to get a consensus on the proposed road name. The first choice was Dairy Barn Rd which had historical value to the people who have resided in the area for a long time. That name met the County's road naming standard so this petition is being processed with a proposed name of Dairy Barn Rd. A map is attached for your reference. Those dwellings currently addressed off Silo Rd will not be affected by the naming of this easement. Further, it is in the public interest to name this easement to further the public health, safety, and welfare.

You have fifteen (15) days to send your response to this notice. If there is no response in opposition received, the County Administrator will consider the roadway name petition and approve or deny the request.

If there is opposition received to the roadway name petition and alternate names are considered, the County Administrator may schedule a public hearing with the Board of County Commissioners. Notice will be mailed at least ten (10) days before the hearing. Those in favor or against the petition will have an opportunity to present their position on the matter before the Board of County Commissioners. The board will approve or deny the request for the roadway change.

The County will notify the property owners owning or abutting the roadway affected stating the outcome of the hearing as to whether the road renaming petition was approved or denied. If approved, the County will notify the property owners affected with their change of address.

A form has been provided below for your convenience if you chose to use it. If you are not opposed to road renaming it is not necessary to notify the County.
