

RESOLUTION NO. 2008- 140

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY FLORIDA, APPROVING THE TERMS OF A MEMORANDUM OF AGREEMENT FOR THE CONSTRUCTION AND MAINTENANCE OF MAST ARM PAINT AT THE INTERSECTION OF SRA1A AT MICKLER ROAD IN ST. JOHNS COUNTY.

WHEREAS, St. Johns County has agreed to maintain mast arm paint at the intersection of SR A1A at Mickler Road; and

WHEREAS, both Parties want to enter into agreement as delineated in the attached Document ("Mickler SR A1A paint MOA."); and

WHEREAS, the County Agrees to Maintain the Facility to FDOT Design Standards per the FDOT Agreements; and

WHEREAS, the County has determined that it is in the interests of the County to execute the MOA.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA AS FOLLOWS:

Section 1: The above recitals as hereby incorporated into the body of this Resolution and adopted as findings of fact.

Section 2: The Board of County Commissioners hereby approves the terms, provisions, conditions, and requirements of the Maintenance Agreement between the Florida Department of Transportation and St. Johns County, Florida, and authorizes the County Administrator to execute the Agreement on behalf of the County.

Section 3: The Clerk of Circuit Court is instructed to file the Agreement in the public records of St. Johns County, Florida.

**MEMORANDUM OF AGREEMENT
BETWEEN
THE FLORIDA DEPARTMENT OF TRANSPORTATION
AND
ST. JOHNS COUNTY**

THIS AGREEMENT, made and entered into this _____ day of _____, _____, by and between the STATE OF FLORIDA, DEPARTMENT OF TRANSPORTATION, hereinafter called the "DEPARTMENT" and the ST. JOHNS COUNTY, hereinafter called the "AGENCY".

WITNESSETH

WHEREAS; the DEPARTMENT is preparing to undertake a project which is known as the intersection modifications SR A1A at Mickler Road, in St. Johns County, Florida, which will be of benefit to the AGENCY; and

WHEREAS; the AGENCY has agreed to maintain the painted mast arms for this project on SR A1A within DEPARTMENT right-of-way at Mickler Road as shown on the approved plans and/or permits.

WHEREAS; the AGENCY, by Resolution No. _____ has authorized its officers to execute this Agreement on its behalf.

NOW, THEREFORE, in consideration of the premises, the parties agree:

1. The DEPARTMENT will undertake projects and obtain federal approval for participation, if necessary, which may include but not be limited to, design, right-of-way, permits, construction and other activities to facilitate satisfactory completion of projects within the limits described above. Upon completion and acceptance by the DEPARTMENT, the AGENCY will assume the responsibility for management and maintenance of the project. All terms of this agreement are subject to legislative budget approval.

2. The AGENCY agrees to maintain the painted mast arms on SR A1A at Mickler Road and agrees to bear all costs associated with the maintenance of the mast arms including painting and/or replacement.
