A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE RELEASE BY QUIT CLAIM DEED OF INTEREST OF AN EASEMENT AREA DESIGNATED FOR UTILITIES WITHIN TWO TRACTS DESIGNATED FOR ADDITIONAL RIGHT OF WAY ALONG STATE ROAD 16 IN THE PLAT OF ASHLEY OAKS SUBDIVISION TO THE FLORIDA DEPARTMENT OF TRANSPORTATION AND AUTHORIZING THE COUNTY ADMINISTRATOR TO EXECUTE THE QUIT CLAIM DEED.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

- Section 1. The above recitals are incorporated by reference into the body of this Resolution and such recitals are adopted as findings of fact.
- Section 2. The Quit Claim Deed is hereby accepted by the Board of County Commissioners and the County Administrator is hereby authorized to execute said deed.
- Section 3. A certified copy of this Resolution shall be forwarded forthwith to the State of Florida Department of Transportation, Post Office Box 1089, Lake City, Florida, 32056-1089.
- Section 4. The Clerk of Circuit Court is instructed to record the Quit Claim Deed in the Official Records of St. Johns County, Florida.
