A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, CHANGING A ROAD NAME FROM LEWIS STREET TO SCHEIDEL WAY; PROVIDING AN EFFECTIVE DATE

WHEREAS, the St. Johns County Land Development Code (LDC) at Section 6.02.03.D and Section 336.05, Florida Statutes, provides that the Board of County Commissioners has the authority to rename roads, except State roads designated by number by the FDOT, lying outside the boundaries of any incorporated municipality; and

WHEREAS, the LDC provides procedures for naming and renaming roads at the Board of County Commissioners' initiative; and

WHEREAS, the subject roadway was named Lewis Street on the plat of the Afro American Subdivision recorded March 18, 1926 in Map Book 4, Page 8 of the public records of St. Johns County, Florida; and

WHEREAS, a request has been made to the Board of County Commissioners to change the road name from LEWIS STREET to SCHEIDEL WAY for that portion of Lewis Street lying between Four Mile Road and San Pedro Avenue; and

WHEREAS, Herb Scheidel has contributed to Habitat for Humanity of St. Augustine/St. Johns County for many years; and

WHEREAS, Mr. Scheidel was a man who thought positively and set goals; not just his own goals, but the goals he dreamed for others; and

WHEREAS, Mr. Scheidel contributed to the community through scholarships and education incentive programs through the Scheidel Family Foundation; and

WHEREAS, Lewis Street is the site of the next Habitat Community; and

WHEREAS, it is fitting and in the public interest to memorialize the name of Scheidel; and

WHEREAS, the Board of County Commissioners has found it to be in the public interest to change the name of this street;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida that, effective immediately:

LEWIS STREET, lying between Four Mile Road and San Pedro Avenue, is hereby renamed and shall hereafter be known as SCHEIDEL WAY.
