WHEREAS, Fruit Cove Utility filed a Notice of Abandonment on or about February 15, 2008; and

WHEREAS, on April 14, 2008, the Court appointed St. Johns County as the Receiver of this abandoned system; and

WHEREAS, the St. Johns County Utility has operated Fruit Cove Utility since the County was appointed Receiver; and

WHEREAS, all ownership interests have been transferred to the County; and

WHEREAS, it is in the best interests of the abandoned utility to be operated as part of the larger County Utility system.

NOW THEREFORE, BE IT RESOLVED, by the Board of County Commissioners of St. Johns County, Florida, that:

Section 1. The above Recitals are hereby incorporated into the body of this Resolution, and are adopted as Findings of Fact.

Section 2. The Fruit Cove Utility system be incorporated into the St. Johns County Utility system and operated as an integral part of the larger system.

Section 3. All rules, regulations, rates and fees will be as provided for in accordance with St. Johns County Ordinance 2006-73, as amended by the Board of County Commissioners from time to time.

Section 4. This resolution shall take effect November 1, 2008.
