

RESOLUTION 2008 - 89

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, RECOGNIZING UNANTICIPATED REVENUES OF \$9,755.00 FROM THE HARTFORD INSURANCE COMPANY TO THE ST. JOHNS COUNTY SUPERVISOR OF ELECTIONS, AND TO ADJUST THE REVENUE AND EXPENDITURE BUDGET OF THE ST. JOHNS COUNTY SUPERVISOR OF ELECTIONS IN RECOGNITION OF SUCH UNANTICIPATED REVENUES, AND AUTHORIZE THE EXPENDITURE OF SUCH UNANTICIPATED REVENUES, IN ORDER TO PURCHASE REPLACEMENT EQUIPMENT**

**WHEREAS**, the St. Johns County, Florida Supervisor of Elections' (Supervisor of Elections) operating budget is annually prepared prior to knowing the actual amount of revenues which may be received by unanticipated sources; and

**WHEREAS**, the Supervisor of Elections, when preparing the budget for Fiscal Year 2008, did not anticipate receiving \$9,755.00 from the Hartford Insurance Company; and

**WHEREAS**, the above-referenced unanticipated revenues will be received, in order to settle a claim filed by the Supervisor of Elections, associated with damage/loss of equipment due to water; and

**WHEREAS**, the above-referenced unanticipated revenues of \$9,755.00 from the Hartford Insurance Company will be expended by the Supervisor of Elections, in order to purchase replacement equipment; and

**WHEREAS**, the above-referenced unanticipated revenues from the Hartford Insurance Company exceed the Supervisor of Elections' Fiscal-Year 2008 budget by \$9,755.00.

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida, that:


1. The above recitals are incorporated by reference into the body of this resolution and such recitals are adopted as findings of fact.
2. Unanticipated revenues of \$9,755.00 from the Hartford Insurance Company to the St. Johns County, Florida Supervisor of Elections be recognized and authorize the expenditure of such unanticipated revenues by the St. Johns County, Florida Supervisor of Elections, in order to purchase replacement equipment.
3. The St Johns County, Florida Supervisor of Elections revenue and expenditure budget be adjusted to account for the unanticipated revenues from the Hartford Insurance Company in the amount of \$9,755.00 for Fiscal-Year 2008.
