

RESOLUTION 2009 - 106

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, RECOGNIZING UNANTICIPATED REVENUES OF \$200,280 FROM A FLORIDA DEPARTMENT OF TRANSPORTATION PUBLIC TRANSIT BLOCK GRANT AND AUTHORIZE THEIR EXPENDITURE BY ST. JOHNS COUNTY FOR TRANSIT OPERATIONS AND TO ADJUST THE TRANSIT REVENUE AND EXPENDITURE BUDGET IN RECOGNITION OF THESE FUNDS.

WHEREAS, the County budget is annually prepared prior to knowing the amount of revenues which may be received by the Florida Department of Transportation for transit expenditures; and

WHEREAS, St Johns County Florida, when preparing the budget for Fiscal Year 2009, did not anticipate receiving Florida Department of Transportation grant revenues for transit operations; and

WHEREAS, the Supplemental Joint Participation Agreement, Financial Project (FP) # 418441-1-84-05 made available Public Transit Block Grant revenues in the amount of \$200,280 to provide operating assistance for transit operations; and

WHEREAS, these unanticipated revenues from the Florida Department of Transportation Public Transit Block Grant in the amount of \$200,280 will be expended by St Johns County for transit operations; and

WHEREAS, these unanticipated revenues from the Florida Department of Transportation Block Grant funds exceed the St. Johns County Fiscal Year 2009 budgeted transit amounts by \$200,280.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, that:

1. The above recitals are incorporated by reference into the body of this resolution and such recitals are adopted as findings of fact.
2. Unanticipated revenues of \$200,280 from a Florida Department of Transportation Public Transit Block Grant be recognized and authorize their expenditure for St Johns County transit operations
3. The St Johns County Transit Fund revenue and expenditure budget be adjusted to account for the unanticipated revenues from the Florida Department of Transportation Public Transit Block Grant in the amount of \$200.280 for Fiscal Year 2009.
4. To the extent that there are typographical or administrative errors that do not change the tenor, or concept of this Resolution, then this Resolution may be revised without the subsequent approval of the Board of County Commissioners.
