

RESOLUTION NO. 2009-327

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING AND AUTHORIZING THE EXECUTION OF SUPPLEMENTAL AGREEMENT #1 TO THE LOCAL AGENCY PROGRAM AGREEMENT BETWEEN THE STATE OF FLORIDA AND ST JOHNS COUNTY FOR CONSTRUCTION OF VARIOUS SIDEWALKS ON DEL MONTE DRIVE, VARELLA AVENUE, AND DURBIN CREEK BOULEVARD ; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the intent of Supplemental Agreement # 1 is to reduce the amount of the Local Agency Program Agreement to match the bid amount for the project.

WHEREAS, the State of Florida Department of Transportation (the "DEPARTMENT"), and St. Johns County (the "COUNTY") desire to revise the Local Agency Program Agreement as enumerated on Supplemental Agreement # 1; and

WHEREAS, Supplemental Agreement # 1 to the Original Agreement is attached and incorporated to this Resolution; and

WHEREAS, the COUNTY has reviewed the terms, provisions, and requirements of Supplemental Agreement # 1, and has determined that accepting the terms of the Agreement, will service the interests of the County.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AS FOLLOWS:

Section 1. The above recitals are hereby incorporated into the body of this Resolution, and are adopted as Findings of Fact.

Section 2. The Board of County Commissioners hereby approves the terms, conditions, provisions, and requirements of the attached Supplemental Agreement # 1 between the State of Florida, Department of Transportation and St. Johns County, Florida, and authorizes the County Administrator, or designee, to execute the Agreement Amendment, on behalf of the County.

Section 3. The Board of County Commissioners authorizes the County Administrator, or designee, to execute any other paperwork associated with, or necessary to accomplish, the overall goal set forth in the Agreement Amendment.

Section 4. To the extent that there are typographical or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval of the Board of County Commissioners.

Section 5. This Resolution shall become effective immediately upon its adoption.
