**A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING THE RETIRED COUNTY EMPLOYEE HEALTH INSURANCE RATE CHANGES FOR 2010; PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, the St. Johns County Insurance Committee annually reviews the Rate Schedule for Health Insurance for Retired County Employees; and

**WHEREAS**, the St. Johns County Insurance Committee has determined that for 2010 an adjustment is necessary in the Rate Schedule for Health Insurance for Retired County Employees; and

**WHEREAS**, the St. Johns County Insurance Committee has approved a revised/adjusted 2010 Rate Schedule for Health Insurance for Retired County Employees; and

**WHEREAS**, a copy of the 2010 Rate Schedule for Health Insurance for Retired County Employees is attached hereto, and incorporated herein; and

**WHEREAS**, the Board of County Commissioners of St. Johns County, Florida must approve the revised/adjusted 2010 Rate Schedule for Health Insurance for Retired County Employees, prior to the effective date of the Rate Schedule.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida, that:

**Section 1.** The above recitals are incorporated into the body of this Resolution, and such recitals are adopted as Findings of Fact.

**Section 2.** The attached and incorporated Rate Schedule approved by the St. Johns County Insurance Committee is approved and adopted by the Board of County Commissioners of St. Johns County Florida.


**Section 3.** The approved and adopted Rate Schedule shall be effective as of January 1, 2010.


