

**RESOLUTION NO. 2009-82**

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, NAMING THE PUBLIC FACILITY LOCATED AT 201 W LATTIN STREET HASTINGS, FLORIDA 32145 THE SHELL REGAN COMMUNITY RESOURCE CENTER; PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, the Board of County Commissioners of St. Johns County established a policy for the naming of public facilities adopted as Resolution 99-152; and

**WHEREAS**, said policy would encourage facility names that describe the public facility, its geographic location, and its historical or ecological relationship to the indigenous region; and

**WHEREAS**, the subject facility has been unnamed since its purchase by the County in 1991; and

**WHEREAS**, Shell Regan owned and operated the Regan Agency in Hastings and provided Crop Insurance and other services to the agricultural community; and

**WHEREAS**, Shell Regan was extremely active in the Hastings Rotary Club and served as its president on several occasions; and

**WHEREAS**, Shell Regan was outstandingly committed to the Hastings community in serving its less fortunate citizens to include actively working for health care needs for the indigent population, providing health care for migrant farm workers, serving as Chair for the Patient Centered Health Care Network and securing grants to prevent and treat diabetes; and

**WHEREAS**, Shell Regan provided a long and esteemed service in the County as an instrumental contributor to the resources within the Hastings community; and

**WHEREAS**, Shell Regan has for generations been recognized as a pillar of the Hastings community; and

**WHEREAS**, it is fitting and in the public interest to memorialize the name of Shell Regan; and

**WHEREAS**, the Board of County Commissioners has found it to be in the public interest to name this facility in furtherance of the public health, safety and welfare;

**NOW, THEREFORE BE IT RESOLVED**, by the Board of County Commissioners of St. Johns County, Florida, and effective immediately:

1. That the public facility located at 201 W Lattin Street, Hastings, Florida 32145, is hereby named and shall hereafter be known as the "Shell Regan Community Resource Center."
2. This exceptional action is recognized as a unique distinction, and shall prevail over any previous St. Johns County Rule, Policy or Resolution pertaining to the naming of public facilities.
