

RESOLUTION 2009 - 86

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING A PROGRAM OF PROJECTS AND SUBMITTAL OF A SECTION 5307 URBANIZED AREA GRANT FOR \$948,514 IN PUBLIC TRANSPORTATION ASSISTANCE FROM THE AMERICAN RECOVERY AND REINVESTMENT ACT OF 2009 TO BE USED IN THE CONSTRUCTION OF A ST JOHNS COUNTY PUBLIC TRANSPORTATION FACILITY

WHEREAS, St Johns County has been apportioned \$948,514 in public transportation capital funding from the American Recovery and Reinvestment Act of 2009; and

WHEREAS, this funding will be applied for through a Federal Transit Administration (FTA) Section 5307 Urbanized Area Grant; and

WHEREAS, this apportionment is designated for use as capital funding in the construction of a new St Johns County Public Transportation Facility; and

WHEREAS, a Program of Projects (POP) (**which is attached hereto, and incorporated herein**) was developed by the recipient of these funds; and

WHEREAS, this POP is used as the basis for the submittal of this Section 5307 Urbanized Area grant; and

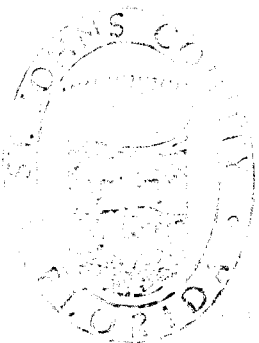
WHEREAS, as required by FTA guidelines, the Board of County Commissioners of St. Johns County has conducted a public hearing on the POP, and approved such POP; and

WHEREAS, no local match will be required for this grant.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, that:

1. The above recitals are incorporated by reference into the body of this resolution and such recitals are adopted as findings of fact.
2. The Program of Projects, used as the basis for this grant, is approved.
3. The County is authorized to submit a Section 5307 Urbanized Area Grant using the approved Program of Projects as the basis for that submittal.
4. No local match is required for this grant.

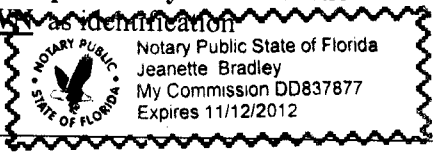
