

RESOLUTION 2010 - 110

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, RECOGNIZING UNANTICIPATED REVENUE OF \$437,902 FROM THE FLORIDA ENERGY AND CLIMATE COMMISSION AND AUTHORIZING EXPENDITURE BY ST. JOHNS COUNTY FOR THE RE-TIMING AND SYNCHRONIZATION OF TRAFFIC LIGHTS FOR SIGNALIZED ARTERIALS, AND PROVIDING TRAINING, PROMOTING ENERGY EFFICIENCY, AND TO ADJUST THE ENGINEERING AND BUILDING DEPARTMENTS REVENUE AND EXPENDITURE BUDGETS IN RECOGNITION OF THESE FUNDS.

WHEREAS, the County budget was prepared prior to applying for and receiving funding from the Florida Energy and Climate Commission as per County Resolution 2010-10, which authorized the Environmental Division to proceed with a grant application; and

WHEREAS, the Florida Energy and Climate Commission Grant Agreement, (GA) # ARE025 provides additional revenue to the County Engineering Department and the County Building Department for specific additional Department activities; and

WHEREAS, this unanticipated revenue from the Florida Energy and Climate Commission Energy Efficiency Conservation Block Grant fund exceeds the St. Johns County Fiscal Year 2010 budgeted amount by \$437,902; and

WHEREAS, there was no match requirement for this funding opportunity therefore there is no General Revenue Fund reduction to the County for matching dollars. The County did identify \$199,462 **from non-cash in kind contributions** to maximize our award potential which brings the total project to \$637,364.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, that:

Section 1. The above recitals are incorporated by reference into the body of this resolution and such recitals are adopted as findings of fact.


Section 2. Of the \$437,902, the County Engineering Department is awarded \$276,000, in order to re-time and synchronize traffic lights for signalized arterial roadways, and the County Building Department is awarded \$161,902, in order to provide technical assistance, workshops and training, promoting energy efficiency.

Section 3. The St. Johns County General Revenue Fund shall be adjusted to account for this unanticipated revenue in the amount of \$437,902 for Fiscal Year 2010.


