

RESOLUTION 2011 - 225

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING A PROGRAM OF PROJECTS, THE SUBMITTAL OF A SECTION 5307 URBANIZED AREA GRANT FOR \$661,519 BASED ON THE PROGRAM OF PROJECTS AND THE EXECUTION OF THE GRANT ONCE AWARDED BY THE FEDERAL TRANSIT ADMINISTRATION IN ACCORDANCE WITH CHAPTER 53, TITLE 23 UNITED STATES CODE

WHEREAS, the Federal Transit Administration (FTA) has been authorized under Chapter 53, Title 23 United States Code to award federal public transportation assistance; and

WHEREAS, St Johns County as a designated recipient has been apportioned \$661,519 in public transportation assistance funding from the FTA; and

WHEREAS, this funding will be applied for through a FTA Section 5307 Urbanized Area Grant; and

WHEREAS, this apportionment is designated for use as operating and capital funding for public transportation assistance in St Johns County; and

WHEREAS, a Program of Projects (POP) (**which is attached hereto, and incorporated herein**) was developed by the recipient of these funds; and

WHEREAS, the POP is used as the basis for the submittal of the Section 5307 Urbanized Area grant; and

WHEREAS, as required by FTA guidelines, the Board of County Commissioners of St. Johns County must conducted a public hearing on the POP and approve such POP as submitted; and

WHEREAS, \$423,000 will be used for operating and requires a 50% match; and

WHEREAS, the 50% match of \$423,000 will come from the County's contribution to transit, fare box revenue, and funds from an FDOT Block Grant; and

WHEREAS, \$238,519 will be for capital that requires a 20% match; and

WHEREAS, the 20 % match will be a soft match of toll revenue credits provided by the State of Florida; and

WHEREAS, the \$661,519 will be included in the St Johns County 2011/2012 fiscal year budget; and


WHEREAS, once the Section 5307 Grant is awarded by the FTA it will be executed by St Johns County.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, that:

1. The above recitals are incorporated by reference into the body of this resolution and such recitals are adopted as findings of fact.
2. The Program of Projects, used as the basis for this grant, is approved.
3. The County Administrator or his designated representative is authorized to submit a Section 5307 Urbanized Area Grant using the approved Program of Projects as the basis for that submittal.
4. The 50% match of \$423,000 for operating will come from the County's contribution to transit, fare box revenue, and funds from an FDOT Block Grant.
5. The 20% match for \$238,519 in capital will be a soft match of toll revenue credits provided by the State of Florida
6. The County Administrator or his designated representative is authorized to execute the Section 5307 grant once awarded by the Federal Transit Administration.
7. The \$661,519 in revenue from this grant will be included in the St Johns County 2011/2012 fiscal year budget.
8. To the extent that there are typographical or administrative errors that do not change the tenor, tone, or concept of this Resolution, then this Resolution may be revised without subsequent approval of the Board of County Commissioners.

A Program of Projects (POP) has been developed in accordance with the FY 2011 North Florida TPO Transportation Improvement Program (TIP). This POP includes operating and capital costs in support of the current, coordinated paratransit and fixed-route service for the St. Johns County. This Program of Projects budget, as approved, will represent this years Section 5307 Urbanized Area Grant submission.

Operating funds are 50% Federal Transit Administration and 50% non-federal. Capital funds are 80% Federal Transit Administration and 20% local/state. The non-federal portion of operating cost is county contribution to public transportation, Farebox and Florida Department of Transportation Public Block Grant. Capital projects are matched with toll revenue credits (non-cash or soft match).
