# RESOLUTION NO. 2011 - 333

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE, TO PURCHASE AND TO EXECUTE A PURCHASE ORDER FOR NEW CAT 430E-IT LOADER BACKHOE

#### RECITALS

WHEREAS, the County desires to enter into a contract with Ring Power Corporation to purchase CAT 430E-IT Loader Backhoe; and

WHEREAS, the scope of the project shall consist of the purchase of Loader Backhoe; and

WHEREAS, through the County's piggybacking off the Florida Sheriff's Association, Florida Association of Counties & Florida Fire Chief's Association contract #11-19-0907, Ring Power selected as the most qualified respondent to enter into a contract with the County to perform the work referenced above; and

WHEREAS, the project is being funded by the Road & Bridge Department; and

WHEREAS, the County has reviewed the terms, provisions, conditions and requirements of the Contract (attached hereto, an incorporated herein) and finds that entering into the Contract serves a public purpose.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

- Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as finds of fact.
- Section 2. The County Administrator, or designee, is hereby authorized to purchase New CAT 430E-IT Loader Backhoe from Ring Power Corp. ("Ring Power").
- Section 3. The County Administrator, or designee, is further authorized to execute A Purchase Order with Ring Power on behalf of the County for the purchase of New CAT 430E-IT Loader Backhoe as specifically provided in Florida Sheriff's Association, Florida Association of Counties & Florida Fire Chief's Association contract #11-19-0907.

Section 4. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.
