A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE BOARD CHAIR TO EXECUTE THE RELEASE OF PHOSPHATE, MINERALS, METALS AND PETROLEUM RESERVATIONS AND RELEASE OF RELATED RIGHTS OF ENTRY AND EXPLORATION DOCUMENT, ON BEHALF OF THE BOARD, IN CONNECTION WITH PROPERTY THAT WAS DECLARED SURPLUS AND WILL BE CONVEYED TO MELDRIM HERITAGE TIMBERLANDS.

RECITALS

WHEREAS, pursuant to Florida Statute Section 270.11(3) there has been a written request from the legal counsel for Meldrim Heritage Timberlands, ("Meldrim") attached hereto as Exhibit "A", incorporated by reference and made a part hereof, to release the mineral reservations that are normally reserved in all County Deeds; and

WHEREAS, Resolution 2011-25 authorized conveyance of certain county surplus property to Meldrim. Said mineral reservations, and in particular the right to mine and develop, is a cloud on the title to the property; and

WHEREAS, the execution of a Release of Phosphate, Minerals, Metals and Petroleum Reservations and Release of Related Rights of Entry and Exploration document, attached hereto as Exhibit "B", incorporated by reference and made a part hereof, would remove the cloud on the title. The executed mineral release form will be recorded; and

WHEREAS, to the extent that there are typographical, scriveners or administrative errors that <u>do not</u> change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

Section 1. The above recitals are incorporated by reference into the body of this Resolution and such recitals are adopted as findings of fact.

Section 2. The Board of County Commissioners hereby approves the form of Release of Phosphate, Minerals, Metals and Petroleum Reservations and Release of Related Rights of Entry and Exploration and authorizes the Board Chair to execute the Release.

phosphate, minerals and metals that are or may be in, on, or under the said land and an undivided one-half interest in all petroleum that is or may be in, or on, or under said land with the privilege to mine and develop the same."
