## RESOLUTION NO. 2011-

RESOLUTION  $\mathbf{BY}$ THE **BOARD OF** COUNTY COMMISSIONERS OF ST. **JOHNS** COUNTY, FLORIDA. APPROVING THE TERMS AND AUTHORIZING THE CHAIR TO EXECUTE **DEED** COUNTY TO **CONVEY** CONSERVATION EASEMENTS PROPERTY TO ST. JOHNS RIVER WATER MANAGEMENT DISTRICT.

### **RECITALS**

WHEREAS, St. Johns River Water Management District (WMD) has requested St. Johns County convey fee ownership of 80 acres that are now encumbered with Conservation Easements by County Deed, attached hereto as Exhibit "A"; and

WHEREAS, this property was originally purchased in 2001 for wetland mitigation for transportation projects for the Holmes Boulevard and West Augustine Infill Housing projects; and

WHEREAS, currently St. Johns County has the enforcement responsibilities of the Conservation Easements requirements of ensuring the site is not being disturbed, trespassed upon, debris being dumped and required to monitor the invasive plant species. This would transfer these responsibilities to WMD; and

WHEREAS, the WMD is requesting the mineral reservations be removed from the County Deed by letter, and there is a letter from WMD stating the County has satisfied their mitigation requirements under permit #'s 4-109-103407-1 and 4-109-64712-1, attached hereto as Exhibit "B", and Exhibit "C" incorporated by reference and made a part hereof; and

WHEREAS, conveyance of this property will allow WMD to take over management of this sight to secure a perimeter boundary and a fire break.

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida, as follows:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as findings of fact.

Section 2. The Board of County Commissioners hereby approves the terms and authorizes the Chair to execute a County Deed to convey the property with Conservation Easements to St. Johns River Water Management District.

**Section 3.** To the extent that there are typographical errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.

Section 4. The Clerk is instructed to send the original County Deed to Land Management Systems to have St. Johns River Water Management District record in the Public Records.
