A petition to rename Prime Outlets Blvd to Outlet Mall Blvd was submitted to the County where at least 51% of the owners signed the petition. Per the St. Johns County Land Development Code Article VI Section 6.02.03 a notice was sent on May 7th, 2012 to the adjoining land owners and the owners of the subject roadway, if any. The owners had 15 days to respond to the notice with any objections to the road renaming petition. No responses were received. The roadway name change has been considered and is hereby approved by the County Administrator or his designee.

Notice of Intent to Rename Prime Outlets Blvd to Outlet Mall Blvd

The purpose of this notice is to advise you that a petition to rename the above roadway has been received by the County. That petition (see attached) has been signed by at least 51% of the abutting property owners (7 of 12) and at least 51% of the roadway owners (5 of 7). This petition is being processed in accordance with the St. Johns County Land Development Code Article VI Section 6.02.03. If you are in favor of the name Outlet Mall Blvd there is no other action or response required.

You have fifteen (15) days to send your response to this notice if you are opposed to the name. If there is no response in opposition received, the County Administrator will consider the roadway name change petition and approve or deny the request.

If there is opposition received to the roadway name change petition and alternate names are considered, the County Administrator may schedule a public hearing with the Board of County Commissioners. Notice will be mailed at least ten (10) days before the hearing. Those in favor or against the petition will have an opportunity to present their position on the matter before the Board of County Commissioners. The board will approve or deny the request for the roadway name change.

The County will notify the property owners owning or abutting the roadway affected stating the outcome of the hearing as to whether the road renaming petition was approved or denied. If approved, the County will notify the property owners affected with their change of address.

You may notify the County by US Mail (St. Johns County Land Management Systems Department, Attention: Lisa Burney, 500 San Sebastian View, St. Augustine, Florida, 32084) or Fax to 904-827-6995. A form has been provided for your convenience if you chose to use it. If you are not opposed to the road renaming it is not necessary to notify the County.
