

RESOLUTION NO. 2012-203

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING THE TERMS, PROVISIONS, CONDITIONS, AND REQUIREMENTS OF AN AGREEMENT BETWEEN ST. JOHNS COUNTY, FLORIDA, AND EPIC COMMUNITY SERVICES, INC. AND AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE, TO EXECUTE THE AGREEMENT ON BEHALF OF ST JOHNS COUNTY.

WHEREAS, the County and Epic Community Services, Inc. entered into a Contract, providing treatment services, parent education, and prevention services for Juvenile Drug Court participants; and,

WHEREAS, the County and Epic Community Services, Inc. now seek to amend the Contract to extend its duration until September 30, 2012 subject to the same terms and conditions and no additional dollars; and,

WHEREAS, the St. Johns County Board of County Commissioners have reviewed the provisions contained in the proposed amendment, attached hereto and incorporated herein; and,

WHEREAS, amending the Contract to extend its duration serves a public purpose and the interests of the citizens of St. Johns County.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AS FOLLOWS:

Section 1. The above Recitals are hereby incorporated into the body of this Resolution, and are adopted as Findings of Fact.

Section 2. The Board of County Commissioners hereby approves the terms, provisions, conditions, and requirements contained in the Amendment to the existing Contract between the St. Johns County, Florida, and Epic Community Services, Inc. to extend the duration until September 30, 2012 and authorizes the County Administrator to execute the Agreement on behalf of the County.

Section 3. To the extent that there are typographical and/or administrative errors and/or omissions that do not change the tone, tenor, or context of this Resolution, then this Resolution may be revised, without subsequent approval of the Board of County Commissioners.

CONTRACT AMENDMENT

THIS AMENDMENT, is made this _____ day of _____, 2012 between St. Johns County Board of County Commissioners, hereinafter referred to as "COUNTY" and Epic Community Services, Inc. a Nonprofit Corporation existing under the laws of the State of Florida and, hereinafter referred to as "PROVIDER".

Whereas, the County and Provider entered into a Contract effective August 12, 2011, providing treatment services, parent education and youth prevention programs for the Juvenile Drug Court Program; and

Whereas, the term of the existing Contract ends August 11, 2012; and

Whereas, the County and Provider wish to extend the expiration date of the contract from August 11, 2012 to September 30, 2012 with no additional funding; and

Now, Therefore, in consideration of the mutual promises and agreements set forth in the existing Contract and this Amendment, the parties hereby agree as follows.

1. The above recitals are true and correct and incorporated herein as though fully set forth below.
2. The term of the existing contract, as adopted and effective on August 12, 2011 is hereby extended to September 30, 2012.
3. The terms, conditions, rights and responsibilities as set forth in the existing Contract will remain in force and effect until September 30, 2012.
4. This amendment becomes effective on the date it is approved by the St. Johns County Board of County Commissioners.

This amendment is hereby made a part of the contract.
