

RESOLUTION NO. 2012 - 240

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE, TO AWARD BID NO. 12-56 AND TO EXECUTE AN AGREEMENT FOR SR 16 WWTP BELT PRESS RELOCATION

RECITALS

WHEREAS, the County desires to enter into a contract with Sawcross, Inc. to provide construction services for SR 16 WWTP Belt Press Relocation; and

WHEREAS, the scope of the project shall generally include furnishing all labor, materials, equipment and other items necessary for the relocation of belt press and associated equipment and installation of a prefabrication steel building; and

WHEREAS, through the County's formal bid process, Sawcross, Inc. was selected as the most qualified respondent to enter into a contract with the County to perform the work referenced above; and

WHEREAS, the project is being funded through the Belt Press Relocation fund (4488-56302-6416-56308) and

WHEREAS, the County has reviewed the terms, provisions, conditions and requirements of the Contract (attached hereto, an incorporated herein) and finds that entering into the Contract serves a public purpose.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as finds of fact.

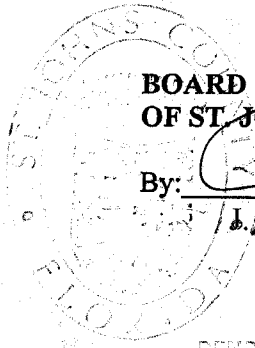
