#### **RECITALS**



#### Introduction

Brockington and Associates, Inc. (Brockington) is pleased to submit this revised proposal for the creation of a series of lesson plans designed to enhance students' understanding of the history of Northwest St. Johns County. On March 12, 2013, Brockington and Associates, Inc., team members Jeff Gardner and Meg Moughan attended a meeting with representatives from the St. Johns County School District, Board of County Commissioners, and the William Bartram Scenic and Historic Highway Management Council. The purposed of the meeting was to discuss the overall project requirements, set out the number of lesson plans to be developed, and to focus and establish learning goals for the lessons. The revisions to the Northwest St. Johns County Lesson Plans project are contained herein and shall replace the information contained in Section 3.2 of our original statement of qualifications dated November 1, 2012.

#### 3.2 Northwest St. Johns County Lesson Plans

#### Project Approach

The History Workshop proposes to develop a series of lesson plans designed to enhance students' understanding of the history of Northwest St. Johns County. In Florida, American history is taught primarily in Grades 2, 4, 5, 8, and 9-12. In teaching, Florida educators utilize both the Common Core State Standards and the Sunshine State Standards. Both sets of standards require that students demonstrate an ability to synthesize information across disciplines; in this way, students might analyze historical documents in an English or geography class. The History Workshop proposes to design a series of lesson plans that address local history and Common Core and Sunshine State standards, that cross disciplines, and that reach a range of academic grades. We will prepare a local history lesson plan for Grade 4, design a sample PARCC assessment for Grade 7 English teachers, and prepare a lesson plan for the Advanced Placement (AP) Human Geography class. Finally, the History Workshop will prepare a general Teachers' Guide for use in teaching the history of Northwest St. John's County.

The History Workshop project manager will oversee all aspects of the Northwest St. Johns County Lesson Plans project and will be the point of contact for the County. The project manager will attend one (1) meeting with the representatives from the County, WBSH, and other stakeholders. The project manager can be available for other meetings as necessary via teleconference or Skype and will be available by telephone or email during regular business hours, Monday through Friday from 8:30 am until 5:00 pm EST. The project manager will provide regular electronic updates to the client regarding project progress.

The History Workshop project manager will develop a project schedule and submit it to the client for review and approval. The project manager will be responsible for ensuring the timely and successful completion of all aspects of the project.

The Northwest St. Johns County Lesson Plans project will be comprised of four units. Each is described below.

#### Project Description

#### 1. Grade 4 Social Studies Lesson Plan

In Grade 4, students explore the history of American Indian culture, the arrival of Europeans in the New World, and the evolution of American history and culture from the colonial period to the present day.

We will develop lesson plan content and activities around the nine Sunshine State Standards for the teaching of American history. The lesson plan will help build vocabulary and reading skills and encourage students to analyze, evaluate, and synthesize information. The lesson plan content will identify the relevant Sunshine State Standard(s), set out learning goals and objectives, and will include a supply list, a teaching strategy, activity sheets, answer keys, and a list of additional resources.

#### 2. Grade 7 Sample PARCC Assessment for English Language Arts/Literacy

Florida is the lead state in a consortium that is developing and implementing new assessments for Common Core standards known as PARCC (Partnership for Assessment of Readiness for College and Careers). We will develop a sample PARCC Assessment that will be used in the Grade 7 English curriculum. Students are required to be tested on their understanding of informational texts and their ability to synthesize different types of factual sources (including digital media). The PARCC Assessment in English Language Arts/Literacy is intended to measure whether students can read and comprehend complex literary and informational text, and can then analyze and write about the text. PARCC requires students to gather information from a single or multiple texts they have read and use that information to develop the writing they do for the assessment We will develop a sample assessment that introduces multiple historical texts, archival sources, visual images, and other sources (such as oral histories). The sample assessment will include a variety of questions and exercises that will require students to integrate sources, analyze arguments, draw conclusions, and draft their own essays that are supported by textual evidence. Seventh grade students will use primary and secondary source materials on the history of St. Johns Country. In creating this, we will draw from the historical narrative developed during the historical studies phase of this project. We will also develop this lesson plan around the English/Language Arts Sunshine State Standard: Reading Standards for Informational Text, Clusters 1 -

#### 3. Grade 11 AP Human Geography Lesson Plan

As stated in the College Board's AP Human Geography course description, the purpose of the class is to "introduce students to the systematic study of patterns and processes that have shaped human understanding, use, and alteration of the Earth's surface. Students employ spatial concepts and landscape analysis to examine social organization and its environmental consequences" (The College Board 2007). Through the course, students develop skills that enable them to utilize maps and analyze spatial data; to recognize and interpret patterns of change; and to understand how different cultural, social, economic factors work together to create cultural landscapes. Topics of study include geography; population theory; cultural patterns and processes; political organization of space, agricultural and rural land use; industrialization and economic development; and cities and urban land use. This course is particularly suited to Brockington and Associates, Inc., and in creating this lesson plan we will draw upon our expertise in conducting archaeology and architecture surveys and GIS and data mapping to create a challenging and innovative educational product. Using the history of Northwest St. Johns County as the focal point, we will create a lesson plan that incorporates the historical narrative developed during the historical studies phase of this project; the architectural survey of Northwest St. Johns County, oral histories, maps, visual images, and GIS data. While an AP course is somewhat less tied to Common Core and Sunshine State Standards, we will reference relevant standards including those that fall under the Geography strand of the Social Studies Sunshine State Standard.

#### 4. Comprehensive Teacher's Guide

The History Workshop will use the historical narrative developed during the historical studies phase of this project as the basis for the Teacher's Guide background information; the study also will be a resource for selecting subjects for the lesson plans. The Teacher's Guide will provide educators with all of the information they need to teach the accompanying lesson plans including historical background information, useable historical pictures, and information about other relevant resources.

The following presents a summary of all of the tasks associated with the development of the Northwest St. Johns County Lesson Plans.

#### Project Tasks

- The History Workshop project manager will review the State of Florida curriculum standards and identify specific Sunshine State and Common Core standards the lesson plans will address.
- The History Workshop project manager will review the historical narrative developed during the historical studies phase of the project to identify specific subjects for the lesson plans.
- The History Workshop project manager will use the historical study as the basis for the Teacher's Guide that will accompany the lesson plans.
- The History Workshop will develop an outline of concepts for each lesson plan that sets out preliminary student learning objectives and lesson strategy and structure. The outline will be provided to the client and its designated stakeholders for review and comment. The lesson plans will identify the relevant Sunshine State Standards, set out learning goals and objectives, and will include a supply list, a teaching strategy, activity sheets, answer keys, and a list of additional resources.
- At this time, the History Workshop can meet with the client to review and discuss the outline.
- Upon acceptance of the outline, the History Workshop will develop a draft of the Teacher's Guide and the accompanying lesson plans and submit the document to the client for review. The project manager can meet with the client to review the draft lessons.
- The History Workshop will address all client comments to the draft and prepare a final document.
- The final Teacher's Guide and lesson plans will be prepared in PDF format and delivered to the client on disk (maximum of 25 copies). This will permit easy upload of the lessons to the Web if desired.

**Introduction:** William Bartram Scenic and Historic Highway (WBSH) travels through several unique unincorporated river communities (such as, Fruit Cove / Julington Creek, Switzerland Point / Hallowes Cove and Orangedale) and begins at the Duval / St. Johns County boundary line which continues south along the SR 13 where it ends at the SR 13 / SR 16 intersection.

One of the main purposes of the Florida Scenic Highway program is to increase the Scenic Highway's visibility, heighten the traveler experience while communicating the Scenic Highway's Story (Grand Vision) to the traveler.

<u>General Project Description</u> - St. Johns County is requesting the services of a professional consultant / firm to create the following products:

- 1. Northwest (NW) St. Johns County historic study including the identification of major historic structures.
- 2. Historic lesson plans for the St Johns County School Board
- 3. Video of William Bartram life's story
- 4. Historical story line write-ups for Florida Frontiers weekly radio magazine, which comes on Monday at 6:30 pm on WJCT.

**Scope of Work:** NW St. Johns County Regional History - The consultant / firm shall document the history as well as the major historic structures related to the history of Northwest St Johns County from the sixteenth (16<sup>th</sup>) century through the twenty first century (21<sup>st</sup>), until the year 2000.

• Northwest St. Johns County has a lengthy history that goes back to the sixteenth century. The first inhabitants life focuses mainly along the St Johns River; although, their lives were also influenced by the inhabitants who lived in the City of St. Augustine. This study will create a historical narrative of the Northwest St. Johns and identify both the unique characteristics of inhabitants living along the St. Johns River, as well as the influence the City of St. Augustine had on this area of the County. The consultant will document the major Northwest St. Johns County historical events from the sixteenth (16<sup>th</sup>) century through twenty first century (21<sup>st</sup>), until the year 2000.

Historical topics that should be addressed within this study include, but are not limited to, the following:

- Native Americans (Aqua Dulce and Missions)
- Seminole incursions
- Indian Towns in the 16<sup>th</sup> and 17<sup>th</sup> century
- Development of Mission Outpost
- British rice and indigo plantations
- Lumber mills,
- Turpentine harvesters
- Cattle ranches
- Citrus Groves and Growers
- Small farms during the territorial and early statehood
- Civil War
- Civil War gunboats
- Steamboats
- Railroad construction
- Tocoi
- San Diego de Helaca
- San Diego de Salumato
- Picolata
- Mill Creek
- Establishment of African-American communities after the war

- Impact of World War I & II
- Lagging behind in the 20<sup>th</sup> century
- Racial strife and conflict
- Impact of modern infrastructure (i.e., electricity, road construction, etc....)
- Impact of modern development

Historic structures related to major historic events in Northwest St. Johns County will also be identified and discussed in this study and will be addressed and discussed further within the overall history.

According to the Historic Properties Survey of St. Johns County, there are approximately 80 historic structures located within Northwest St. Johns County and in 2000-2001 the individual Master Site File forms were prepared and recorded with the Division of Historic Resources. The consultant / firm shall only update thirty two (32) historic master site file forms located just within the boundaries of the WBSH corridor based on the information identified in the historical analysis.

In addition, the consultant / firm shall address the following:

- The newly created Florida Master Site File forms shall be analyzed with the goal of identifying an accurate historic context for these structures within the historical development of the corridor area.
- Provide recommendations on the historical significance of these structures both individually and as potential historic districts.
- Provide recommendations on effective management strategies for historic preservation within this corridor.
- Re-evaluate the historic significance of the 32 historic structures located within the WBSH corridor boundaries to determine the historic structures historic significance base on the NW St Johns County historical analysis and new understanding of its historic context.
- All 32 updated master site file forms need to be submitted to the Division of Historic Resources for their records.

The Northwest St Johns County history report shall include an Executive Summary, Acknowledgements, Table of Contents, List of Figures, List of Tables, Criteria and Methodology, Timeline Historical Development, Descriptions and Analysis of the Historical Resources, Recommendations and Bibliography sections.

The final document should be similar to the quality of previously written reports created for St. Johns County such as the <u>Elkton Hastings Historic Farmstead Survey</u> or the West Augustine Historic District Assessment Survey (which can be found on the County's web site at <a href="http://www.sicfl.us/Environmental/HistoricResources.aspx">http://www.sicfl.us/Environmental/HistoricResources.aspx</a>).

**NW St Johns County Lesson Plans -** The consultant/firm shall create lesson plans based on the history of NW St Johns County historical study, as stated above.

Lesson plans shall be created for the history of NW St. Johns County. Consultants shall provide examples of lesson plans they have prepared in the past and proposed to provide in the future.

Identified below are a few web sites that are good examples of lesson plans the William Bartram Scenic and Historic Highway members would like to see the consultant created for St Johns County School Board. The consultant should figure on several meeting with the WBSH to determine the specifics of the content they would like to see in the lesson plans and shall coordinate with the St Johns County School Board to determine the specifics of final lesson plans.

**William Bartram Scenic and Historic – Historical Video -** The consultant/ firm shall create a ten (10) minute historical timeline video of William Bartram life's story.

William Bartram is credited for being the first American naturalist. Bartram traveled initially with his father, John Bartram, and later by himself, from 1765 to 1777. Both he and his father traveled through eight (8) different states in the United States, including North and South Carolina, Alabama, Georgia, Florida, Mississippi, Louisiana and Tennessee.

He and his father's explorations were identified in William's journal that was later published in a book entitled "Travels". This single document increased the world's knowledge of natural science, botany, botanical art, American Indian culture and influenced English literature.

In 1977 the Bartram Trail Conference was held to perpetuate and memorialize William Bartram life work. Over the years, the Bartram Trail organization has continued to educate the public about William Bartram's life. The Bartram Trail organization's web site (<a href="http://bartramtrail.org/">http://bartramtrail.org/</a>) provides valuable information which can be utilized as a resource to create the William Bartram video. The new President of this organization is Chuck Spornick. Chuck's email address is <a href="mailto:libcds@emory.edu">libcds@emory.edu</a>.

Another web site that provides valuable information about William Bartram life's work is Dr Schafer and his web site address is <a href="http://unf.edu/floridahistoryonline">http://unf.edu/floridahistoryonline</a> Dr. Schafer was a history professor at the University of North Florida and he has authored numerous books, educational films and articles. His recent book is entitled, "William Bartram and the Ghost Plantations on the St. Johns River."

These web site sources can be utilized in the creation of the William Bartram time line historical video. Prior to creating the actual video, a story script must be created, presented and approved by the WBSH Corridor Management Council (CMC).

The video shall be similar in quality as the WBSH timeline historical video show on YouTube under the name of William Bartram Scenic & Historic Highway – Teaser. Pictures of both William Bartram and his father can be utilized instead of filming a live William Bartram re-enactor.

After the CMC approves the video story script, then the consultant / firm can proceed with the completion of the video until it is seventy five percent (75%) completed. At this time, the video will be reviewed by the county staff for possible changes prior to its final production.

**Florida Frontiers weekly radio magazine -** Florida Frontiers is a weekly radio magazine of the Florida Historical Society. There web address is <a href="https://www.wjct.org">www.wjct.org</a>. Every Monday night at 6:30 pm. historical broad casts are made about Florida's past.

Twelve (12) historical radio magazine write ups will be created based on the information presented in the NW St Johns County historical write up. The writer will write the radio magazine stories based on important historical events that have occurred in NW St. Johns County. Such information will be used by the WBSH members when they discuss these historical events with the Florida Frontiers is a weekly radio magazine.

These historical write ups will be presented one time to the William Bartram Scenic & Historic Highway (WBSH) Corridor Management Council (CMC) members to solicit feedback prior to being finalized.

**Schedule -** Upon the completion of the signed contract, the consultant / firm shall proceed as follows:

- 25% Completion of one quarter of the NW St Johns County historic study and video script within 2 months
- 50% Completion of the NW St Johns County historic study and video production in addition to, 25% completion of the NW St Johns County Lesson Plan and Florida Frontiers radio magazine write-ups within 4 months
- 75% Completion of the NW St Johns County historic study and video production in addition to, 50% completion of the NW St Johns County Lesson Plan and Florida Frontiers radio magazine write-ups within 6 months
- 100% Completion of the NW St Johns County historic study, lesson plan, William Bartram Video and Florida Frontiers radio magazine write-ups within 8 months

#### **Deliverables**

County staff members as well as the WBSH CMC members will review and edit these documents prior to final production.

- At one hundred percent (100%) completion, the consultant / firm shall provide hard copies (as noted below) and four (4) digital CD Rom copies of each of the following:
  - 1. Northwest (NW) St. Johns County historic study including the identification of major historic structures. 5 hard copies
  - 2. Historic lesson plans for the St Johns County School Board 5 hard copies
  - 3. Historical story line write-ups for Florida Frontiers weekly radio magazine 5 hard copies
- At one hundred percent (100%) completion, the consultant / firm shall provide one hundred (100) copies of the William Bartram video.

**Funding Source** - The consultant should be made aware that funding for these projects is provided through the Federal Highway Administration's (FHWA's) National Scenic Byway (NSB) grant program and St Johns County. Since this is a federally funded grant project, the selected consultant or consultants will

- C. Compliance with Regulations: The Consultant shall comply with the regulations relative to nondiscrimination in Federally-assisted programs of the U.S. Department of Transportation Title 49, Code of Federal Regulations, Part 21, as they may be amended from time to time, (hereinafter referred to as the Regulations), which are herein incorporated by reference and made a part of this Agreement.
- D. Nondiscrimination: The Consultant, with regard to the work performed during the contract, will not discriminate on the basis of race, color, national origin, sex, age, disability, religion or family status in the selection and retention of subconsultants, including procurements of material and leases of equipment. The Consultant will not participate either directly or indirectly in the discrimination prohibited by Section 21.5 of the Regulations, Including employment practices when the contract covers a program set forth in Appendix B of the Regulations.
- E. Solicitations for Subcontracts, Including Procurements of Materials and Equipment: In all solicitations made by the Consultant, either by competitive bidding or negotiation for work to be performed under a subcontract, including procurements of materials and leases of equipment, each potential subcontractor or supplier shall be notified by the Consultant of the Consultant's obligations under this contract and the Regulations relative to nondiscrimination on the basis of race, color, national origin, sex, age, disability, religion or family status.
- F. Where any information required of the Consultant is in the exclusive possession of another who fails or refuses to furnish this information, the Consultant shall certify to the Local Agency, Florida Department of Transportation, Federal Highway Administration, Federal Transit Administration, Federal Aviation Administration, and/or the Federal Motor Carrier Safety Administration as appropriate, and shall set forth what efforts it has made to obtain the information.
- G. Sanctions for Noncompliance: In the event of the Consultant's noncompliance with the nondiscrimination provisions of this contract, the Local Agency, Florida Department of Transportation shall impose such contract sanctions as it or the Federal Highway Administration, Federal Transit Administration, Federal Aviation Administration, and/or the Federal Motor Carrier Safety Administration may determine to be appropriate including, but not limited to,

- (1) withholding of payments to the Consultant under the contract until the Consultant complies and/or
- (2) cancellation, termination or suspension of the contract, in whole or in part.
- H. Accordingly, United States Code, Title 18, Section 1020, is hereby incorporated by reference and made a part of this Agreement.
- M. It is understood and agreed that if the Consultant at any time learns that the certification it provided the Department in compliance with 49 CFR, Section 26.51, was erroneous when submitted or has become erroneous by reason of changed circumstances, the Consultant shall provide immediate written notice to the Department. It is further agreed that the clause titled "Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion Lower Tier Covered Transaction" as set forth in 49 CFR, Section 29.510, shall be included by the Consultant in all lower tier covered transactions and in all aforementioned federal regulation.
- N. The Department hereby certifies that neither the consultant nor the consultant's representative has been required by the Department, directly or indirectly as an express or implied condition in connection with obtaining or carrying out this contract, to or implied condition in connection with obtaining or carrying out this contract, to
  - (1) employ or retain, or agree to employ or retain, any firm or person, or

(2) pay, or agree to pay, to any firm, person, or organization, any fee, contribution, donation, or consideration of any kind;

The Department further acknowledges that this agreement will be furnished to a federal agency, in connection with this contract involving participation of Federal-Aid funds, and subject to applicable State and Federal Laws, both criminal and civil.



# 3.0 Ability to Perform Required Services



# 3.1 Northwest St. Johns County Regional History and Architectural Survey


# **Project Approach**

Brockington proposes to develop a historic context of Northwest St. Johns County for use in the promotion and preservation of the WBSH. Documenting the area's major historical events from the sixteenth century through the beginning of the twenty-first century, the historical narrative will focus on the social, cultural, and architectural history of the St. Johns River, its scenic communities such as Fruit Cove, Switzerland, and Orangedale, and its diverse inhabitants. In addition



to developing a regional history for the area, Brockington will also complete the documentation and evaluation of historic buildings and structures located within Northwest St. Johns County. The documented historic buildings and structures will be incorporated into the larger historic context, providing a better understanding of the area's history and development and laying the groundwork for future cultural resource studies and preservation policies. The documentation of Northwest St. Johns County's significant architectural resources and the preparation of an extensive regional history will assist County staff with their ongoing commitment to local preservation planning, heritage tourism, and public education and will determine how historic resources along the WBSH should be protected, managed, and interpreted.

Brockington offers the County a trained staff that has the skills and experience to prepare extensive historic contexts and cultural resources reports and to document and evaluate historic buildings and structures in Florida. Brockington's experienced team of architectural historians can identify, describe, and evaluate eligible and contributing resources based on the NRHP criteria of significance, the integrity of resources, and relevant historic contexts. Under the guidance of the lead manager, Brockington's architectural historian will oversee all aspects of the Northwest St. Johns County Regional History and Architectural Survey and will work closely with County staff. Brockington's team will develop a project schedule and submit it to the County for review and approval, ensuring the timely and successful completion of all project tasks. The following presents a summary of the tasks associated with the research, development, and production of the Northwest St. Johns County Regional History and Architectural Survey.

# **Project Tasks**

- Project manager Charles Philips and project architectural historian Paige Wagoner will meet (onsite) with the County and other interested stakeholders to discuss the overall project requirements and the methods to be employed, set out specific historical topics and historic resources that should be addressed and researched, and review the project schedule. This meeting will provide the framework for the historic context and architectural survey and will guide activities throughout the project.
- The project architectural historian will review completed Florida Master Site File (FMSF) historical structure forms within Northwest St. Johns County. This data will be used as the basis for the reconnaissance level survey that will identify and document significant architectural resources within the project area.
- The project architectural historian will undertake a windshield reconnaissance survey to identify

historic properties and highlight common architectural styles and historical themes within Northwest St. Johns County. As outlined in the National Register Bulletin #24, a windshield reconnaissance level survey is useful in ascertaining "a general picture of the distribution of different types and styles [of architectural resources], and of the character of different neighborhoods" (Parker 1985:35-36). During the reconnaissance level survey, the project architectural historian will photograph individual historic buildings, potential historic districts, and other significant sites. Photographs and information collected from the reconnaissance survey will be incorporated into the historic context.

- In coordination with County staff, the project architectural historian will select thirty-two (32) resources located within the WBSH corridor for an intensive level survey. In accordance with Florida Division of Historic Resources' Cultural Resource Management Standards & Operational Manual (2012), this survey will include field verification, photographic documentation, and an update of FMSF forms for the thirty-two (32) selected properties. Brockington will also reevaluate the thirty-two (32) resources located with the WBSH corridor to determine historical significance based on NRHP's criteria and relevant historic contexts. The location of each historic resource will be recorded on USGS topographic and/or county tax maps utilizing GIS technology. Draft and final FSMF forms, including associated maps and photographs will be prepared for County review. Brockington will submit the completed forms to the Florida Division of Historic Resources.
- The project manager and project architectural historian will gather background information from local repositories to help identify, assess, and interpret the aboveground historic resources and to develop the relevant historic context. This research will focus on the historical topics outlined in the RFQ (Indian towns, Spanish missions, British plantations, citrus growers, African American communities, etc.), historic buildings and structures identified in the reconnaissance and intensive surveys, and other historical themes identified by Brockington's

project team and County staff. The background research task will consist of archival research, oral interviews, and the collection of historic photographs and maps.

- After completion of the background research and architectural surveys, the project historians will prepare an extensive regional history focused on Northwest St. Johns County. As outlined in the RFQ, the report will include:

  - Acknowledgments
  - Table of Contents
  - List of Figures
  - List of Tables
  - Criteria and Methodology
  - Timeline of Historical Development
  - Descriptions and Evaluation of Historic Resources

Recommendations on the historical significance of documented buildings and structures as well as effective preservation and management strategies for historic resources will be included in the report. A draft of the history will be provided to the County in the form of an unbound hard copy and an electronic copy (PDF) for review and comment (review period 30 days). Brockington's team will address all comments to the draft text.

Upon receipt of the County's comments, Brockington's team will revise the draft history, making

all necessary changes. Within 30 days of receipt of County comments, Brockington will provide five (5) bound copies and four (4) digital copies (on DVD-R) of the historical study to the County. Brockington will also submit final FMSF forms of thirty-two (32) historical structure forms to the County and the Florida Division of Historic Resources.

# 3.2 Northwest St. Johns County Lesson Plans

## **Project Approach**

The History Workshop proposes to develop a series of lesson plans designed to enhance students' understanding of the history of Northwest St. Johns County. In Florida, American history is taught primarily in Grades 2, 4, 5, 8, and 9-12. In particular, Grades 4, 5, and 8 explore the history of American Indian culture, the arrival of Europeans in the New World, and the evolution of American history and culture from the colonial period to the present day.

Since the proposed lesson plans will be based on the Florida's curriculum standards for Social Studies, we recommend developing the lesson plan content and activities around the Sunshine State Standards for these three grade levels.

The proposed educational products will include a Teacher's Guide and a series of lesson plans. The History Workshop will use the historical narrative developed during the historical studies phase of this project as the basis for the Teacher's Guide background information; the study also will be a resource for selecting subjects for the lesson plans. The Teacher's Guide will provide educators with all of the information they need to teach the accompanying lesson plans including historical background information, useable historical pictures, and information about other relevant resources. The accompanying lesson plans will be developed for Grades 4, 5, and 8. All of the lesson plans will be designed to meet Florida's Common Core Standards for Social Studies. Each lesson plan will help build vocabulary and reading skills and encourage students to analyze, evaluate, and synthesize information. Each lesson plan will identify the relevant Sunshine State Standard, set out learning goals and objectives, and will include a supply list, a teaching strategy, activity sheets, answer keys, and a list of additional resources. The Teacher's Guide and lesson plans will be will be prepared in PDF format and delivered to the client on disk (maximum of 25 copies). This will permit easy upload of the lessons to the web if desired.

The History Workshop project manager will oversee all aspects of the Northwest St. Johns County Lesson Plans project and will be the point of contact for the County. # 3.3 WBSH Historical Video

### Project Approach

The History workshop proposes to develop a 10-minute video about the life of William Bartram, America's first naturalist. William Bartram and his father John Bartram traveled throughout the southeast during the middle of the eighteenth century collecting information about the region's plants, animals, and people. For a period of time he resided in Northwest St. Johns County. The video will use historic and contemporary photographs, video, information graphics and maps, narration, and music to tell the story in a dynamic and lively manner. The video will be designed as a standalone presentation and will be short enough for incorporation into Web sites or as part of the lesson plans also being developed during this project. We recommend creating the video for an eightgrade-level audience in order to have wide appeal to a variety of viewers including students in earlier



grades and adult audiences. The History Workshop will provide 100 copies of the video in DVD cases.

To develop the video, the History Workshop will review the historical studies document developed as part of this project and undertake additional research about the life and times of William Bartram. The Bartram Trail Conference will be an important source of information. In addition, William Bartram's journal published in 1791 is available online as part of the Documenting the American South project of the University of North Carolina at Chapel Hill. We will use the information gathered during the research phase to develop an outline of the video and to write a script for the narration. The script will be provided to the County and its stakeholders for review. We will gather and digitize photographs and will create two separate information graphic maps. We will record the audio narration and select and secure rights for music. We will film any necessary B-roll or use any existing footage and/or information available from the County, the Bartram Trail Conference, and the WBSH. In addition, the History Workshop has hours of scenic video footage filmed along WBSH as part of a previous video project. With permission, this film may be available for use during this project. The History Workshop will create and edit the video and provide 100 copies on the video on DVD.

The History Workshop project manager will oversee all aspects of the William Bartram Video Project and will be the point of contact for the County. The project manager will attend two (2) meetings with the representatives from the County, the CMC, and other stakeholders. The project manager can be available for other meetings as necessary via teleconference or Skype and will be available by telephone or email during regular

business hours, Monday through Friday from 8:30 am until 5:00 pm EST. The project manager will provide regular electronic updates to the client regarding project progress.

# 3.4 Florida Frontiers Weekly Radio Show Write Ups

#### **Project Approach**

Brockington will provide a series of twelve write ups suitable for a broad-based, statewide educational radio program pertaining to the history of Northwest St. Johns County and the WBSH. Based on the historical context developed for the County and the CMC, we will prepare twelve (12) write ups for submittal to Florida Frontiers: The Weekly Radio Magazine of the Florida Historical Society. This show is produced by the Florida Historical Society

under direction of Dr. Ben Brotemarkle. We will consult with the producer to ensure relevance of the suggested topics for the radio program. Each write up will briefly discuss a subject relevant to the history of Northwest St. Johns County, the WBSH, and the history of the state of Florida and United States.

### **Project Tasks**

- After the background research has been completed, the project historian will compile a master list of potential topics that merit presentation on the Florida Frontiers radio program. These topics will be of sufficient importance to the area and Florida history, have adequate archival materials and or potential interviewees, and/or have existing cultural resources to properly present the story.
- The project historian will consult with the CMC and the County to develop a list of topics to be discussed with the Florida Frontiers radio show.
- The project historian will contact Dr. Brotemarkle at Florida Frontiers and review each topic for the show's interest, eliminating any that the producer does not consider relevant for the radio show.
- The project historian will then consult with the CMC and the County and select twelve topics that will be approved for the final write ups.
- The project historian will then prepare a write up
  of the twelve (12) topics to be submitted to the
  radio program. In the process he will continue
  consultation with the CMC, the County, and other
  subject specialists for interviews or information
  on the topics. Each write-up will include:
  - A suggested title
  - Brief summary of the topic and historic context
  - Description of existing cultural features related to the topic (location of structures, ruins or sites and accessibility)
  - Location of archival materials to be researched
  - Brief discussion and contact information for potential interviewees familiar with the topic
  - Special information that might add to the story or special challenges to raising the topic in a public forum



The project historian will submit the twelve (12) write-ups to the Florida Frontiers radio show and be available for consultation for up to six months to aid CMC and the Florida Frontiers radio show with the presentations.

## **Project Deliverables**

Five hard copies of each of the twelve (12) Florida Frontiers radio show write ups.



Beginning in 2006, the City of Gainesville, Georgia's Community Development Department, contracted with Brockington and Associates, Inc., to conduct a multi-phase community-wide Historic Structural Survey of buildings and other structures in order to develop goals and priorities for historic resources within the city. For the undertaking, a Category I Historic Preservation Fund Grant for Certified Local Governments was used, provided by the National Parks Service and administered by the Georgia Historic Preservation Division, along with matching funds from the City of Gainesville. In an effort to garner public support for the project, the City and Brockington held a series of open house-type forums to encourage participation among the residents, business occupants, and property owners of the resources for each survey phase.

Brockington completed the five-phase survey in 2011, resulting in the documentation of more than 2,500 resources.

Within the survey area, project historians conducted a parcel-by-parcel investigation, recording and documenting each individual residential, institutional, commercial, or recreational resource that fell within survey criteria. In addition, Brockington provided development history summarizing the historical background and influences on the built environment of the region, Hall County, and Gainesville, and an architectural analysis that provides an overview of typical resources in the survey areas and suggests potential Historic Districts within the city. Finally, an analysis of recorded resources was also provided, along with recommendations to help guide future preservation activities in Gainesville.

The survey provides support for local historic designation and better prepare the city's planning and development staff and the Gainesville Historic Preservation Commission in the management of historic resources. The survey is also designed to augment the ongoing, statewide Georgia Historic Resources Survey of buildings, sites, structures, and objects of historical, architectural, and cultural significance.

In 2009, Brockington and Associates, Inc. completed a historic resources survey and National Register of Historic Places (NRHP) nomination for the Bohemian Commercial Historic District in downtown Cedar Rapids, Iowa for the City of Cedar Rapids, Community Development Department. The project was in response to the devastating 2008 flood, which severely impacted valuable historic buildings within the historic district and the surrounding neighborhoods. In an effort to mitigate the loss of several flood-affected residential and commercial properties within the NRHP-listed Bohemian Commercial Historic District, we worked to document the district's remaining buildings and reaffirm the area's eligibility for the NRHP.

As the process of clean-up and rebuilding began, Brockington and Associates conducted a parcel-by-parcel investigation, recording and documenting each residential, institutional, commercial, and recreational resource within the historic district and its two adjacent neighborhoods, the Bohemian South Side and Czech Village. We identified additional architectural resources related to the city's Bohemian and Czech history and culture and recommended that the boundaries of the original historic district should be expanded to include related residential, commercial, and institutional properties. We used the information collected from the historic resources survey to write a new NRHP nomination form that helped further the understanding of the local Bohemian-American story during the nineteenth and twentieth centuries.

Despite the level of destruction in Cedar Rapids' historic Bohemian and Czech neighborhoods, recovery efforts moved forward to restore these neighborhoods and continue the preservation of their rich immigrant history and culture. While many of the historic buildings were lost or damaged by the flood, the identification of new historic resources and the redefinition of the area's historic district helped protect the neighborhood's architectural character and preserve the sense of history and culture for the city's Bohemian and Czech community.



During the Civil War, more than 700,000 Union and Confederate soldiers were taken prisoner. The conditions on both sides were almost unbearable. At some camps, it was typical for one out of every four prisoners to die. The Immortal 600 was a group of Confederate POWs held in the Morris Island stockade in South Carolina, where they were exposed to cannon fire from the Confederate and Union armies.

The History Workshop worked with the Georgia Department of Education, the Federal Highway Administration, and the Georgia Technology Authority to develop the Immortal 600 teaching package, which tells the stories of these Civil War POWs and details the information about the Abandoned Cemetery Act.

In 2009 Charleston County RoadWise (road planning division of Charleston County, SC) employed Brockington and Associates and The History Workshop to conduct documentation, excavation, and public outreach as mitigation for a 250-year old inland rice field system that was going to be impacted by the construction of a new parkway. Brockington documented the rice fields, researched the plantations that the rice fields were associated with, and did partial excavations of two embankments to study construction techniques. Brockington prepared a contextual study of these field systems for the National Register of Historic Places. Brockington designed and produced an outdoor panel/wayside sign and South Carolina roadway historical marker. Additionally, researchers conducted a series of public outreach lectures on the importance of inland swamp rice to South Carolina's history. The History Workshop developed a traveling educational photographic display, an inland rice website that is hosted on Charleston County's website, and produced a video and poster for the 2012 South Carolina Preservation Conference. 


