OF RESOLUTION BOARD COUNTY BY THE COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE CHAIR OF THE BOARD OF COUNTY COMMISSIONERS TO ISSUE A LETTER, ON BEHALF OF THE FLORIDA **DEPARTMENT** COUNTY. TO THE ENVIRONMENTAL PROTECTION OFFICE OF GREENWAYS AND TRAILS, IN SUPPORT OF DESIGNATING THE ENTIRE ST. JOHNS RIVER AS A STATE PADDLING TRAIL OR BLUEWAY

- WHEREAS, the St. Johns River Alliance ("SJRA") seeks to petition the Florida Department of Environmental Protection ("FDEP") Office of Greenways and Trails to designate the entire St. Johns River as a State Designated paddling trail or blueway; and
- **WHEREAS**, St. Johns County has already designated the St. Johns River as a paddling trail and blueway in its St. Johns County Blueways, Greenways and Trails Masterplan; and
- WHEREAS, the River Alliance has requested that all counties adjacent to the St. Johns River issue a letter to the FDEP Office of Greenways and Trails, supporting State designation of the St. Johns River as a paddling trail or blueway; and
- WHEREAS, such State designation would impose no additional funding requirements at County owned boat ramps, launching facilities, or parks along the St. Johns River, but would strengthen the County's position is future efforts to secure grant funding; and
- WHEREAS, it is in the collective best interests of the citizens of St. Johns County to provide a letter to the FDEP Office of Greenways and Trails in support of designating the entire St. Johns River as a State paddling trail or blueway.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AS FOLLOWS:

- **Section 1.** The above Recitals are hereby incorporated into the body of this Resolution, and are adopted as Findings of Fact.
- Section 2. The Board of County Commissioners hereby authorizes the Chair to issue a letter on behalf of St. Johns County to the FDEP Office of Greenways and Trails, supporting efforts to designate the entire St. Johns River as a State paddling trail or blueway.
- Section 3. To the extent that there are typographical and/or administrative errors contained herein that do not change the tone, tenor or concept of this Resolutions, then such errors may be corrected and this Resolution revised without subsequent approval by the Board of County Commissioners.

St. Johns County is pleased to provide this letter of support for the St. Johns River Alliance as they apply to Department of Environmental Protection's Office of Greenways and Trails in an effort to designate the St. Johns River as a State paddling or blueway trail.
