

RESOLUTION NO. 2013 - 250

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE, TO PURCHASE AND TO EXECUTE A PURCHASE ORDER FOR A NEW EXCAVATOR.

RECITALS

WHEREAS, the County seeks to purchase a new Gradall XL3100 Excavator 4X4; and

WHEREAS, in accordance with applicable provisions of the St. Johns County Purchasing Procedure Manual, the County seeks to make a piggyback purchase based upon the Florida Sheriff's Association, Florida Association of Counties & Florida Fire Chief's Association Contract #13-11-0904, from the awarded vendor, Ring Power Corporation, at the awarded price of \$320,334.00; and

WHEREAS, the project is being funded by the Road & Bridge Department; and

WHEREAS, said purchase serves a public purpose.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as finds of fact.

Section 2. The County Administrator, or designee, in accordance with applicable provisions of the St. Johns County Purchasing Procedure Manual, is hereby authorized to purchase a new Gradall XL3100 Excavator 4X4 from Ring Power Corp. ("Ring Power") at a purchase price of \$320,334.00, and further authorized to execute a purchase order for said equipment.

Section 3. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.

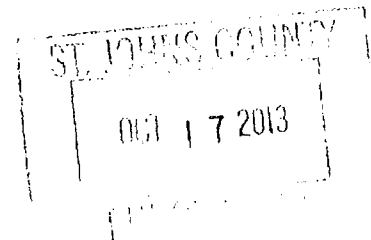
