## RESOLUTION 2013 - 32

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AMENDING THE FISCAL YEAR 2012 GENERAL FUND TO INCLUDE CERTAIN UNANTICIPATED REVENUE AND AUTHORIZE ITS EXPENDITURE BY THE LIBRARY SYSTEM.

## RECITALS

WHEREAS, the St. Johns County operating budget was prepared prior to determining the total amount of donations that would be received by the St. Johns County Public Library System ("Library System"); and

WHEREAS, there are residual funds from Fiscal Year 2012 in the amount of \$40,746 that represents unused donations to the Library System; and

WHEREAS, the current Library Services Expenditure Budget reflects \$29,885 of those donations, leaving \$10,861 in General Fund Reserves; and

WHEREAS, the Public Library System has received additional donations in Fiscal Year 2013 in the amount of \$ 30,397 to date; and

WHEREAS, the Library System seeks recognition of the total amount of donated funds, \$41,258, as current year revenues to enable the appropriation of such funds for use.

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida, that:

- 1. The above Recitals are hereby adopted as legislative findings of fact.
- 2. The Library System expenditure budget shall be adjusted to account for the Fiscal Year 2012 residual balance of unused donations in the amount of \$10,861.
- 3. The General Fund revenue and the Library System expenditure budgets shall be adjusted to account for unanticipated revenue in the amount of \$30,397.
- 4. To the extent that there are typographical, and/or administrative, errors and/or omissions that do not change the tone, tenor, or context of this Resolution, then this Resolution may be revised without subsequent approval of the Board of County Commissioners.
- 5. This Resolution shall be effective on the date of execution.
