**A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE, TO PURCHASE AND TO EXECUTE A PURCHASE ORDER FOR ONE NEW 2015 CATERPILLAR 430F2 IT BACKHOE LOADER**

**RECITALS**

**WHEREAS**, the County seeks to purchase one (1) 2015 Caterpillar 430F2 IT Backhoe Loader; and

**WHEREAS**, in accordance with section 302.6.5.4 of the St. Johns County Purchasing Manual, entitled "Piggyback or Cooperative Purchasing", the County is authorized make said purchase subject to the terms and conditions of Florida Sheriff's Association, Florida Association of Counties & Florida Fire Chief's Association contract #14-12-0904 ("Contract"); and

**WHEREAS**, purchase of the equipment will be funded by the Road & Bridge Department; and

**WHEREAS**, the County has reviewed the terms, provisions, conditions and requirements of the Contract and finds that entering into the Contract for purchase of the equipment serves a public purpose.

**NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA**, as follows:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as finds of fact.


Section 2. The County Administrator, or designee, is hereby authorized to purchase one (1) new Caterpillar 430F2 IT Backhoe Loader.

Section 3. In accordance with the terms and conditions of the Contract, the County Administrator, or designee, is further authorized to execute a purchase order in the amount of \$120,361.00 for purchase of the backhoe loader from Ring Power Corporation.


