- 2. The Board of County Commissioners hereby approves the terms, provisions, conditions, and requirements of the Northeast Florida Library Information Network, and recognizes and appropriates this grant award within the Fiscal Year 2015 General Fund Library Services Budget.
- 3. To the extent that there are typographical or administrative errors that do not change the tone, tenor, or concept of this Resolution, this Resolution may be revised without subsequent approval by the Board of County Commissioners.
