

Comes now J. Russell Collins, Trustee of 402 Third Street Land Trust dated March

1. To vacate, abandon, discontinue and close portions of those certain public streets, alleyways or roads situated in Saint Johns County, Florida, hereinafter more particularly described; to renounce and disclaim any right of Saint Johns County and the public in and to the lands constituting such portions of said streets, alleyways or roads; and to renounce and disclaim any right of Saint Johns County and the public in and to any lands or interest therein acquired by purchase, gift, devise, dedication or prescription for such portions of said streets, alleyways or roads described as follows:
