RECITALS

WHEREAS, Section 6.02.03 B. of the St. Johns County Land Development Code and Section 336.05, Florida Statutes, provides that the Board of County Commissioners has the authority to name roads, except state roads designated by number by the Florida Department of Transportation, lying outside of any incorporated municipality; and

WHEREAS, the Board of County Commissioners has an interest in naming the proposed roadways which will serve to connect SR 9B to Race Track Road and shown on the map attached hereto as Exhibit "A", incorporated by reference and made a part hereof; and

WHEREAS, it is found to be in the public interest to name these roadways on furtherance of the public health, safety and welfare.
