A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE, TO AWARD RFP NO. 15-23 AND TO EXECUTE AGREEMENTS FOR TEMPORARY STAFFING SERVICES

RECITALS

WHEREAS, the County desires to enter into a contract with Staffing of St. Augustine and Kelly Services, Inc. to provide Temporary Staffing Services for St. Johns County; and

WHEREAS, the scope of the services shall consist of an hourly rate for temporary staffing services and temporary-to-permanent recruiting and placement services; and

WHEREAS, through the County's formal <u>RFP process</u>, <u>Staffing of St. Augustine and Kelly Services</u>, <u>Inc. were selected as the most qualified respondents</u> to enter into a contract with the County to perform the work referenced above; and

WHEREAS, the County has reviewed the material terms, provisions, conditions and requirements of the proposed contract (attached hereto, an incorporated herein) and finds that entering into such a contract serves a public purpose; and

WHEREAS, the proposed contract will be finalized after negotiations with Staffing of St. Augustine and Kelly Services, Inc., and will be in substantially the same form and format as the attached draft.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

- Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as finds of fact.
- Section 2. The County Administrator, or designee, is hereby authorized to award RFP 15-23 to Staffing of St. Augustine and Kelly Services, Inc., and to conduct negotiations to provide the services set forth therein.
- Section 3. The County Administrator, or designee, is further authorized to execute an agreement in substantially the same form and format as the attached draft with Staffing of St. Augustine and Kelly Services, Inc. on behalf of the County to provide the scope of services as specifically provided in RFP 15-23.
- Section 4. If after negotiations with Staffing of St. Augustine and Kelly Services, Inc., an agreement cannot be reached, the County administrator, or designee is authorized to award RFP 15-23 to the next successively ranked qualified respondent(s), conduct negotiations and execute an agreement in substantially the same form and format as attached hereto.
- Section 5. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.
