RESOLUTION NO. 2016-13

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE, TO EXECUTE A PARTIAL RELEASE OF UTILITY SERVICE AND REFUND AGREEMENT PURSUANT THE PROPERTY OWNERS REQUEST IN CONNECTION WITH THE PROPOSED IMPROVEMENTS TO FIRST COAST EXPRESSWAY BY THE FLORIDA DEPARTMENT OF TRANSPORTATION.

WHEREAS, the State of Florida Department of Transportation proposes to construct First Coast Expressway in St. Johns County, Florida; and

WHEREAS, in order to complete the Project, it is necessary to release certain property from the Utility Agreement that will be sold to the State of Florida Department of Transportation as stated in the Partial Release of Utility Service and Refund Agreement attached hereto as Exhibit "A," incorporated by reference and made a part hereof; and

WHEREAS, the proposed release has been reviewed by the St. Johns County Utility Department and recommended for approval, as stated in memo attached hereto as Exhibit "B," incorporated by reference and made a part hereof; and

WHEREAS, execution of the Partial Release of Utility Service and Refund Agreement best serves the interest of St. Johns County.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, as follows:

- Section 1. The above Recitals are incorporated into the body of this Resolution and such Recitals are adopted as findings of fact.
- Section 2. The Board of County Commissioners hereby authorizes the County Administrator, or designee, to execute a Partial Release of Utility Service and Refund Agreement in substantially the same form and format as attached hereto as Exhibit "A".
- Section 3. The Board of County Commissioners further authorizes the County Administrator, or designee, to execute any further partial releases of utility service and refund agreements in substantially the same form and format as attached for the property to be encumbered by conservation easements as necessary for completion of the Project.

Section 4. The Clerk is instructed to record the Partial Release in the public records of St. Johns County, Florida.

Section 5. To the extent that there are typographical, scriveners and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.
